## Market Commentary

For the near term we believes the market still has room on the upside, despite its heady run up. However, maintains cautions as we feels geopolitical problems are absolutely at the peak over last 10 years. "Somewhere we feel the US economy is going to show signs of growth putting pressure on currencies across the world vis-à-vis the dollar, which could possibly lead to muted inflows coming into India or maybe some outflows over the next three to nine months. So, there is danger ahead plus there is always the scare that interest rates will go up one day in US. So, between now and the next six to nine months, we are going to have a mishap or a fall; that is going to come. However, for the time being we don't think anything is a problem because money is going on coming. So, over the next 3-5 percent upside in the market, we would say distinctly possible. However, individual stocks wise, there are very few left which feels like going and buying at the present valuations.

## Major Economic Events in AUG 2014

- ✚ Indian economy expanded 5.7 percent in the first quarter of FY15, the highest in nine quarters, against a growth of 4.6 percent in Q4 of 2013-14. The economy grew 4.7 percent in the year-ago period. The economy grew at its highest pace since the fourth quarter of FY12. A market poll had estimated Q1 (April-May-June) FY15 GDP growth to come in at 5.8 percent. The broad range for the Q1 GDP was 5.4-6 percent. The revival in the first quarter was expected to be led by industry. Manufacturing, coming off a low base, was expected to push industries and it did not disappoint. The manufacturing sector grew at 3.5 percent, against a 1.2 percent contraction year-on-year. The mining sector too grew at 2.1 percent versus -3.9 percent YoY.
- ✚ The June IIP data has come in at 3.4 percent against 5 percent on a month-on-month basis. This is much below the market poll estimates of 5.8 percent. The electricity sector grew at 15.7 percent against 6.3 percent, whereas the capital goods sector has shown a tremendous growth at 23 percent against 4.5 percent (M-o-M). The mining sector growth came in at 4.3 percent against 2.7 percent, whereas the consumer goods contracted 10 percent versus 3.7 percent. Even the consumer durables contracted 23.4 percent against 3.2 percent. Manufacturing grew at 1.8 percent against 4.8 percent (M-o-M).
- ✚ The July wholesale price inflation (WPI) came in at 5.19 percent (provisional), marginally higher than market poll of 5.16 percent. The 2013 July wholesale price inflation stood higher at 5.85 percent. Alongside, the government has revised May inflation numbers higher at 6.18 percent, marking it the third revision of prices in recent months. However, July core inflation declined to 3.32 percent against 3.9 percent in the previous month. The movement of the index for the various commodity groups is summarized below.
- ✚ The government rolled out its ambitious financial inclusion programme, the Pradhan Mantri Jan Dhan Yojana (PMJDY), and said about 1.5 crore accounts were opened on 1st day through thousands of camps, exceeding the firstday target of 1 crore accounts. The programme is Prime Minister Narendra Modi's first blockbuster social upliftment scheme and is aimed at improving the lives of millions of India's poor by bringing them into the financial mainstream and freeing them from the clutches of usurious moneylenders, while giving them a modicum of insurance cover.
