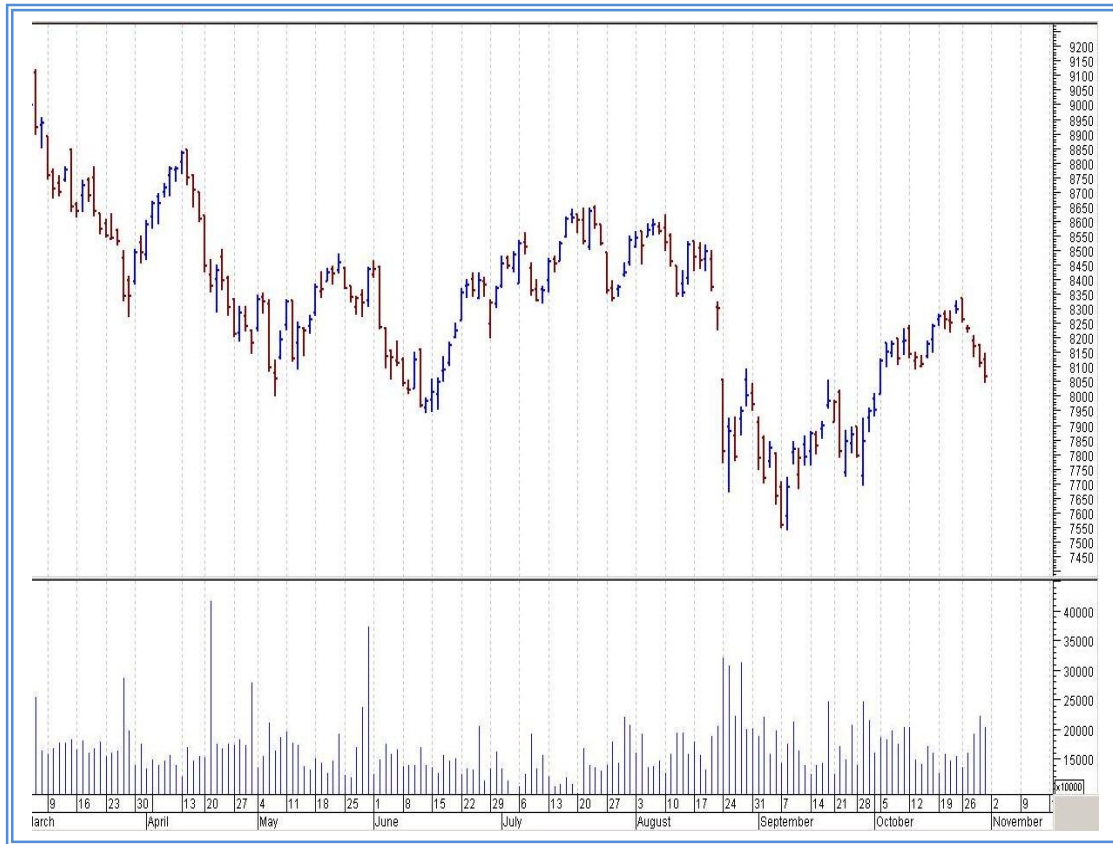

The market fell last week, with the barometer index, the S&P BSE Sensex, falling below the psychological 27,000 mark. The Sensex and the Nifty declined in all five trading sessions during the week. Trading was volatile as traders rolled over positions in the futures & options (F&O) segment from the near month October 2015 series to November 2015 series. The October 2015 derivatives contracts expired on Thursday, 29 October 2015. For the next week Nifty likely to trade in the range between 8100 - 8150 in the upper side and 8000 - 7950 in the lower side.
