

FIIs' FEAST ON LARGE INDIAN STOCKS



This data contain those companies whose share ownership in the latest available quarter reflects a rise in the ownership by Foreign Institutional Investors. Selection is based on a rise in number of shares owned by foreigners. It is quite likely that the ownership of shares may rise but, the share in the overall ownership may decline, or that the rise may be very nominal. It is quite liberal in picking stocks where the foreign ownership of shares in Indian companies has raised.

The query is performed on the information filed by listed companies with the BSE & the NSE. The results of the query are filtered to remove small and illiquid stocks. The data leaves only those companies that have a market capitalization of Rs. 500 crores in the last 30 days, were traded for more than 80 percent of the last 365 traded days.
