 - ➤ U.S. Stocks Retreat as Commodities Rout Resumes; Bonds Advance: - The stronger dollar and a persistent slump in demand from China rekindled a selloff in commodities, while Mario Draghi's signal that he's concerned about global growth weighed on equities from Europe to America.
 - China Speeds up Fiscal Spending in October to Support Growth: - China's government spending surged four times the pace of revenue growth in October, highlighting policy makers' determination to meet this years' growth target as a manufacturing and property investment slowdown weigh on the economy.
 - ➢ Gold Demand Climbs to Two-Year High as Buyers Snap up Bargains: - Buying of gold including bars, coins and jewelry rose to the highest in two years after lower prices spurred demand last quarter. The WGC forecast demand for the year at 4,200 to 4,300 tons, after raising the estimate for central bank buying to a range of 500 to 600 tons, from between 400 and 500 tons, he said. Last year, overall demand totaled 4,217 tons.
 - Draghi Fails to Prop up Stocks While Bonds Climb, Euro Weakens: - Not even Mario Draghi was able to support European stocks Thursday, as they were dragged lower by a dimming outlook for company earnings.
 - ➤ U.S. oil prices slump to 2-month low on stockpile expectations: - U.S. oil prices slumped to a more than two-month low on Thursday, amid expectations weekly supply data due later in the session will show U.S. crude inventories rose for the seventh consecutive week last week.
