

# **MARKET COMMENTARY**

Indian equity benchmarks ended the choppy day of trade slightly in the red on Tuesday as investors remained on sidelines ahead of third quarter earnings results starting next week with Infosys slated to announce its results on January 14, 2016. Immense volatility characterized trading whereby benchmark equity indices kept altering between green and red terrain throughout the session. However, broader indices outperformed benchmarks and garnered gain of over half a percent. For today's trade Nifty likely to trade in the range between 7810 – 7830 in the upper side and 7810 – 7830 in the lower side.

  - ➤ U.S. Stocks Erase Early Gains Following Year-Opening Selloff: - U.S. stocks fluctuated after erasing an early advance, while global equity markets stabilized following the worst year-opening performance for the Standard & Poor's 500 Index in 15 years.
  - WTI oil futures slump to 2-week low ahead of API supply data: - West Texas Intermediate oil prices extended losses from the prior session on Tuesday to hit a two-week low as market players looked ahead to fresh weekly information on U.S. stockpiles of crude and refined products to gauge the strength of demand in the world's largest oil consumer.
  - Natural gas futures slide 3% despite cold weather forecasts: - U.S. natural gas prices fell sharply on Tuesday, even as weather forecasts showed that the U.S. east coast will be colder than normal in the coming week.
  - Gold holds near 4-week high amid safe-haven demand: - Gold prices held near the prior session's four-week high on Tuesday, as investors sought refuge amid instability in the Middle East and fresh concerns over global growth.
  - Copper recovers from Monday's selloff as China moves to calm markets: -Copper prices recovered from the prior session's selloff on Tuesday, as sentiment improved after China's central bank attempted to buoy markets with a \$20 billion cash injection. The People's Bank of China flooded its banking system with 130 billion yuan, or \$19.95 billion, marking the largest cash injection since September.
