## **MARKET COMMENTARY**

Monday's trading session was of consolidation as the Indian frontline indices appeared a bit fatigued and remained in tight band for most part of the day. However, the benchmarks managed to extend the winning momentum for the second consecutive day of trade, as local sentiments continued to show signs of improvement. Investors took some encouragement with Finance Minister Arun Jaitley's statement that the government hopes to pass the landmark Constitution Amendment Bill for national Goods and Services Tax (GST) as well as the bankruptcy and insolvency bill in the second half of the Budget session beginning April 20. Some support also came with the report that overseas investors have bought a net \$1.41 billion worth of shares so far in March, paring this year's outflows to \$1.48 billion. For today's trade Nifty likely to trade in the range between 7565 – 7585 in the upper side and 7525 – 7495 in the lower side.

- Crude oil range->\$33 to \$43.
  - ➤ U.S. Stocks Retreat as Oil Declines; Dollar Gains on Fed Outlook: - U.S. stocks slipped and oil retreated as investors awaited further signals that central banks will continue to support growth and the glut in crude will ease.
  - Economic data around the world suggest the global economy is far from the recession environment that wiped almost \$9 trillion off the value of equities worldwide this year through mid-February, and central banks are indicating they'll support asset prices when needed. The Bank of Japan, which adopted a negative interest rate in January, will conclude a policy review on Tuesday and a Federal Reserve meeting ends Wednesday.
  - ➤ Brent oil falls below \$39 after Iran refuses to join output freeze: Oil prices fell sharply in North American trade on Monday, pulling back from last week's three-month highs after Iran dashed hopes that there would be a coordinated production freeze any time soon.
  - Gold under pressure ahead of BOJ, Fed policy meetings: Gold futures fell sharply in North American trade on Monday, as investors looked ahead to a raft of central bank meetings and rate decisions this week. Market players braced for the Bank of Japan's policy decision due on Tuesday, followed by the Federal Reserve's rate announcement on Wednesday and the Bank of England meeting on Thursday.
  - Fed to sit tight on rates at March meet, hint at hikes to come: The Federal Reserve won't raise interest rates this week, but will likely make clear that as long as U.S. inflation and jobs continue to strengthen, economic weakness overseas won't stop rates from rising fairly soon.
