Traders were seen piling position in Realty, Oil & Gas and Capital Goods stocks while selling was witnessed in Power sector stocks. For today's trade Nifty likely to trade in the range between 7925 – 7945 in the upper side and 7875 – 7845 in the lower side.

 - ➤ U.S. Stocks Slip, Dollar Gains as Economic Data Bolster Fed Case: -U.S. stocks slipped while the dollar advanced with yields on two-year Treasuries after data on inflation and housing signaled the U.S. economy may be strong enough for the Federal Reserve to raise rates this summer.
 - China's ICBC Buys 2,000-Ton London Gold Vault from Barclays: - ICBC Standard Bank Plc expanded its push into London's precious metals market by agreeing to buy one of Europe's largest vaults from Barclays Plc. ICBC Standard, formed last year after Industrial and Commercial Bank of China Ltd. -- China's biggest bank -- bought a controlling stake in Standard Bank Plc's global markets business, expects the purchase of the vaulting business and related contracts to be completed in July, it said in an emailed statement Monday. No financial details were given.
 - Dollar dips against major rivals on Fed rate hike doubts: - The U.S. dollar dipped against a basket of major currencies on Tuesday after U.S. inflation data failed to convince currency traders that the Federal Reserve was moving closer to another interest rate hike.
 - Oil keeps rising, hits 7-month highs on global supply outages: Oil prices rose to fresh seven-month highs in European trade on Tuesday, adding to sharp overnight gains amid mounting concerns over global supply disruptions. Oil prices have been well-supported in recent sessions due to a combination of Nigerian, Libyan and Venezuelan supply outages, declining U.S. shale output and reduced production of Canadian crude as a result of fires in Alberta's oil sands region.
