

MARKET COMMENTARY

Indian stocks markets showed a volte-face on the last day of the trading week, as what started on a promising note ended as a dismal show. Earlier the market started the session on positive note tracking firm trade in other regional markets, but sentiments turned pessimistic in late morning session after IT major Infosys posted lower-than-expected dollar revenue growth in the first quarter and lower guidance of constant currency revenue growth in FY 17 to 10.5 percent -12 percent from 11.5 percent -13.5 percent earlier. For today's trade Nifty likely to trade in the range between 8565 – 8575 in the upper side and 8525 – 8495 in the lower side.

 - Stocks Fluctuate, Dollar Gains as Treasuries Fall amid Data: - U.S. stocks fluctuated after four straight records closes, the dollar rose and Treasuries extended the biggest weekly drop in a year as data on manufacturing and retail sales bolstered optimism in the economy. European equities halted this week's rally amid a deadly terror attack in Nice.
 - Aussie recovers a bit after China GDP comes in better than seen: - The Aussie recovered a bit in Asia on Friday as GDP figures from major trading partner China came in better than expected, though the currency remained down so far on the day.
 - Kuroda Ally Says BOJ Has No Need to Expand Stimulus This Month: - The Bank of Japan has no need to further increase monetary stimulus when the policy board meets this month, said a professor who has collaborated on research with Governor Haruhiko Kuroda.
 - ▶ Bet on Gold-Mining Companies Fuels Jackpot for Soros and Calpers: -Owning shares of major gold producers wasn't very rewarding over the past five years as the plunging price of the metal hurt profit. But in 2016, the industry has delivered huge returns with relatively little prospect for losses.
 - Oil lower but underpinned by China data: Oil futures were lower Friday but received some support from stronger-than expected Chinese economic data. U.S. crude was down 27 cents, or 0.59%, at \$45.41 at 06:45 ET after a low of \$45.06. Brent crude was down 0.61% at \$47.08. Concerns about a global supply glut remain in place but stronger- than-expected Chinese GDP growth lent some support. China's gross domestic product was up 6.7% in the second quarter.
