MARKET COMMENTARY

Thursday turned out to be a daunting session for the Indian equity indices which got pounded by around three fourth of a percent. After trading listless near the neutral lines for most part of the day, domestic gauges crashed like house of card in the last leg of trade, as caution prevailed ahead of corporate results. Further, investors opted to remain on sidelines awaiting progress on the tax reforms bill. Market participants failed to get any encouragement with government's hope on support from regional parties that the Rajya Sabha will clear the indirect tax reform in the first week of August. For today's trade Nifty likely to trade in the range between 8535 – 8555 in the upper side and 8495 – 8465 in the lower side.

 - ➤ U.S. Stocks Fluctuate amid Earnings as ECB Sends Bonds Lower: - Earnings continued to set the tone on global equity markets, as equities from Europe to the U.S. fluctuated with investors looking for evidence that economic growth is bolstering profits. Government bonds retreated as traders were disappointed the European Central Bank wasn't more forceful in signaling fresh stimulus is coming.
 - Dollar index pares losses, reapproaches 4-month peak: The dollar pared losses against the other major currencies on Thursday, as strong U.S. housing sector data lent support and as upbeat remarks by European Central Bank President Mario Draghi failed to sustainably ease global growth concerns.
 - Natural gas futures edge higher after weekly storage data: U.S. natural gas futures edged higher in North America trade on Thursday, after data showed that natural gas supplies in storage in the U.S. rose less than expected last week. The U.S. Energy Information Administration said in its weekly report that natural gas storage in the U.S. in the week ended July 15 rose by 34 billion cubic feet, below forecasts for an increase of 39 billion.
 - Oil turns lower as glut concerns linger: - Oil prices erased <u>overnight gains</u> in North American trade on Thursday, turning lower amid ongoing concerns over a global supply glut.
 - ➢ Gold stays near 3-week low after U.S. data, Draghi comments: Gold prices were little changed in North American trade on Thursday, staying close to a three-week low hit overnight as market players digested mixed U.S. data and comments from European Central Bank President Mario Draghi.
