Market Commentary

The Nifty50 started on a buoyant note and continued its upward journey. Surprisingly, India VIX -- which is a measure of volatility -- is trading at its lowest level since December 2014. A low VIX suggests that there is a very high bullish consensus among traders and investors. Well, this is a slightly worrying factor. FII's cumulatively invested Rs 8,800 crore in August. Passenger vehicle sales saw a scorching growth of 16 per cent in August, which is the loudest signal on the health of the economy. This is one macroeconomic signal which is infallible in estimating the vibrancy of the economy. The bull case scenario based on passenger vehicle sales is the most reliable indicator of the Indian stock market since the last three decades and the same looks true this time as well. The Nifty50 has broken out from a sideways consolidation range and started its upward journey. The next significant resistance is placed at the 9,000 level, which creates scope for further upside in the medium term. The indicators after turning neutral and have again started to rise, confirming that this rally will sustain till it faces an upside resistance at the 9,000 level. Traders can start long positions and buy on dips with a stop loss at 8,550. Investors are advised to invest selectively at current level. Traders with existing long positions should put a trailing stop loss at 8,550 on the Nifty50.

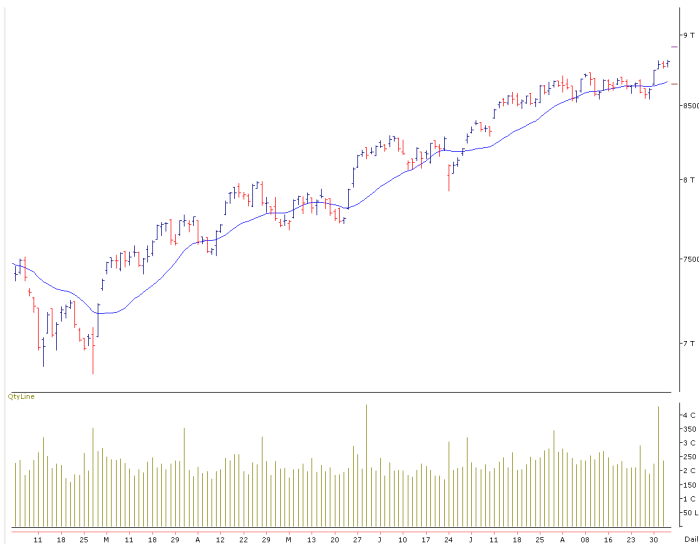

Major Events Aug 2016

- India's gross domestic product (GDP) grew 7.1% in the first quarter of FY16-17, against 7.9% in the fourth quarter of 2015-16.
- India Apr-July 2016 Fiscal deficit stood at Rs 3.93 lakh crore, or 73.3 percent of the Budget estimates for 2016-17. Core sector clocks 3.2% growth in July slower than the 5.2% recorded in June.
- Coal India's Coal Production of 32.43 MT vs. target of 40.89 MT for Aug 2016. Offtake of 36.72 MT vs. target of 44.51 MT for Aug 2016
- Government imposes Stock Limit On Sugar Mills To Check Prices During Festive Season.
- Two-wheeler major Hero MotoCorp posted a 28 per cent jump in sales at 6,16,424 units in August. It had sold 4,80,537 units in August 2015.
- Total sales of TVS Motor Company grew by 30.1 per cent to 2,38,984 units against 1,83,653 units in August 2015.
- Carmaker Maruti Suzuki India (MSI) launched its first light commercial vehicle (LCV) Super Carry in the country priced at Rs 4.03 lakh (ex-showroom, Ahmedabad). The company said its domestic sales in August rose 12.3 per cent to 1,19,931 units, from 1,06,781 units in August 2015.
- Bajaj Auto total sales at 3,25,347 units in August as against 3,41,965 in the same month a year ago.
- Honda Motorcycle & Scooter India (HMSI) has registered 25 percent sales growth in domestic market in August 2016, and stood at 4,66,342 units when compared with 3,73,136 units during same month last year. The company has witnessed 25 percent total sales growth for the month of August 2016 and sold 4,92,416 units two wheelers as against 3,95,196 two wheelers during August 2015.
