MARKET COMMENTARY

The market has ended with marginal gains. The Sensex closed up 30.49 points or 0.1 percent at 27673.60 and the Nifty up 10.05 points or 0.1 percent at 8583.40. About 1722 shares have advanced, 1079 shares declined, and 180 shares are unchanged. Infosys, HUL, HDFC, Lupin and Wipro were major losers while GAIL, L&T, Reliance and TCS were gainers in the Sensex. Infosys shares tumbled as much as 5.3% to their lowest since July 20, 2015 after the company cut its fiscal-year revenue growth target for a second time in three months on an uncertain business outlook.

For today's trade Nifty likely to trade in the range between 8600-8625 in the upper side and 8565-8540 in the lower side

 - Stocks Rebound as Commodities Advance after China Alarm Subsides:
 - Stocks gained with commodities as Chinese inflation data assuaged investor angst fueled by a shock slump in exports.
 - Dollar holds onto gains despite downbeat UoM report: - The dollar held onto gains against the other major currencies on Friday, hovering close to a seven-month peak despite the release of downbeat U.S. consumer sentiment data, as expectations for a 2016 rate hike continued to support. In a preliminary report, the University of Michigan said its consumer sentiment index fell to 87.9 in October from 91.2 the previous month, disappointing expectations for a rise to 91.9. The data came after another report showed that U.S. retail sales rose 0.6% in September, in line with expectations and after a revised 0.2% falls the previous month. Core retail sales, which exclude automobiles, increased by 0.5% last month, beating expectations for a 0.4% gain.
 - Crude prices rally despite mixed U.S. inventory data: U.S. oil futures rallied on Friday, despite news of a rise in U.S. stockpiles, as a decline in distillates and gasoline inventories helped. The U.S. Energy Information Administration said on Thursday that <u>U.S. crude stocks</u> rose for the first time in six weeks, increasing by 4.9 million barrels in the week to October 7 to 474 million barrels.
 - ➤ Gold prices hold steady, eyes on U.S. data: Gold prices held steady on Friday, as a higher U.S. dollar weighed on the precious metal although investors remained cautious ahead of U.S. retail sales and consumer sentiment data, as well as a speech by Federal Reserve Chair Janet Yellen due later in the day.
