

MARKET COMMENTARY

Indian equity benchmarks snapped the two days winning streak and ended the session with cut of around three fourth of a percent. The lackadaisical trade dragged the Nifty below 8000 mark on the expiry day of F&O series. The markets made a gap-down start and traded in red in early deals as the sentiments were under pressure as the US Fed gave more signals that it was inclined towards a rate hike in December. The impact of demonetisation which shocked the economy also continued to weigh on investors. For today's trade Nifty likely to trade in the range between 7985 – 8015 in the upper side and 7945 – 7935 in the lower side.

NEWS & RUMOURS:

- Gold (Spot Dollar) major support \$1161/\$1139 & Resistance \$1229/\$1258.
- Crude oil range->\$43 to \$53.
 - Dollar Surge Weighs on Emerging Markets as Copper Extends Gains: -The dollar's gains reverberated across emerging markets as the case for multiple U.S. interest-rate increases strengthened. Copper surged.
 - Dollar continues to hover at 14-year highs in quiet trade: - The dollar continued to hover at a 14-year peak against the other majors currencies on Thursday, amid ongoing optimism over the U.S. economy and as trading volumes were set to remain thin for the Thanksgiving holiday.
 - Oil prices edge higher in holidaythinned trade: - Oil prices edged higher on Thursday as uncertainty over a planned OPEC-led output cut and thin liquidity due to the U.S. Thanksgiving holiday weighed.

<u>U.S. crude</u> was at \$48.06 per barrel at 1205GMT, up 12 cents from its last settlement.

Brent crude futures were trading at \$49.05, up 10 cents from their last close. Trade volumes remained low due to the U.S. holiday. Sentiment was also hit by ongoing uncertainty over a planned oil production cut led by the Organization of the Petroleum Exporting Countries, aimed at reducing a global supply glut and support falling oil prices.

➢ Gold breaks below \$1200, further downside seen: - Gold fell through the key psychological level of \$1,200 on Wednesday, pressured lower by the strong dollar. The precious metal touched lows of US\$1,179.75, a level not seen since February 8. Gold prices could now come under siege, which will likely see falls to as low as \$1168.13 and beyond.


