# **MARKET COMMENTARY**

Indian equity markets concluded the week on a sluggish note as the benchmarks showcased an unenthusiastic performance on Friday and settled with moderate cuts of around two tens of a percent. Sentiments remained subdued with the minutes of the RBI's April 6 policy meeting suggest that the next move of the central bank will likely be a hike in key policy rates. All members expressed concern about stickiness in core inflation and believed that the disinflationary effect of demonetisation will be transient. For today's trade Nifty likely to trade in the range between 9085 - 9135.

  - ➤ U.S. Stocks Drop as Euro Slips before French Vote: Markets Wrap: - U.S. stocks retreated; while Treasuries climbed as markets struck a cautious tone ahead France's presidential election. The nation's bonds and the euro slipped before Sunday's vote that puts the future of the common currency in play.
  - Dollar holds onto modest gains after positive U.S. data: The dollar held onto modest gains against other major currencies on Friday, after the release of positive U.S. housing sector data, but the greenback's upside was expected to remain limited as markets looked on to the first round of France's presidential election on Sunday. The U.S. National Association of Realtors said existing home sales increased by 4.4% in March to5.71 million units from the previous month's revised total of 5.47 million units. Analysts had expected a 2.5% rise to 5.60 million units last month.
  - Oil steady ahead of rig count: Oil edged lower Friday ahead of the latest U.S. rig count data. Oil settled lower the previous session amid concerns about increased U.S. output and remains on course for losses for the week. Higher U.S. output offsets the positive impact of a possible extension of an output cut deal by major producers. OPEC and non-OPEC producers are cutting production by 1.8 million barrels a day in the first half. A decision on a possible extension of that deal is expected to be taken on May 25. Baker Hughes is due to release the latest weekly U.S. rig count. The rig count has risen for 13 weeks in a row.
