# **MARKET COMMENTARY**

Benchmark indices ended the session on an extremely strong note, with the midcaps too bouncing back after days of correction. Sensex clocked a fresh record high, surpassing its earlier mark of 30712, while the Nifty gained nearly 2 percent.

The Sensex was up 448.39 points at 30750.03, while the Nifty ended 140.95 points higher at 9501.50. The market breadth was healthy as 1,875 shares advanced against a decline of 807 shares, while 152 shares were unchanged.

  - U.S. Stocks Add to Records; Oil Slips on OPEC: Markets Wrap: - U.S. stocks rose to fresh records as retailer results boosted confidence in the American consumers' ability to jump start economic growth. Oil retreated from a five-week high after OPEC extended plans to limit production without deepening the cuts.
  - ➤ Dollar holds onto moderate gains in subdued trade: The dollar held onto moderate gains against other major currencies in subdued trade on Thursday, helped by the release of positive U.S. jobless claims data, although the minutes of the Federal Reserve's latest policy meeting continued to weigh.
  - U.S. natural gas futures hit session lows after supply data: U.S. natural gas futures fell to session lows on Thursday, following data showing that natural gas supplies in storage in the U.S. rose more than expected last week. 聽Futures were at around \$3.303 prior to the release of the supply data after rising to a session high of \$3.351 earlier. The U.S. Energy Information Administration said in its weekly report that natural gas storage in the U.S. rose by 75 billion cubic feet in the week ended May 19, above forecasts for a build of 71 billion.
  - ➢ Oil prices sink 3%, WTI breaks below \$50 ahead of press conference: - Oil prices sank more than 3% with the barrel of West Texas Intermediate oil breaking below \$50 as market participants await confirmation that major oil producers will extend their agreement to cut output by 1.8 million barrels per day (bpd) for another nine months through March


