Equity benchmarks as well broader markets erased all gains in late trade and ended on a flat note Tuesday, but the Nifty managed to hold its psychological 9,600-mark ahead of Federal Reserve meeting starting today.

The 30-share BSE Sensex was up 7.79 points at 31,103.49 while the 50-share NSE Nifty fell 9.50 points to 9,606.90 despite positive global cues.

 - ➤ U.S. Stocks Near Record, Dollar Slips as Fed Looms: Markets Wrap: - U.S. stocks rebounded from a two-day slide to approach fresh all-time highs as technology shares staged a comeback. The dollar weakened and Treasuries fluctuated as the Federal Reserve policy meeting kicked off.
 - > Sterling higher on UK inflation data, dollar slips lower: The pound rose on Tuesday after data showing that UK annual inflation hit a four-year high last month, while the dollar slipped lower against a currency basket as investors awaited the outcome of this week's Federal Reserve policy meeting.
 - ➤ Gold falls to 7-day low as Fed meeting kicks off: Gold prices fell to a more than one-week low in North American trading on Tuesday, ahead of an expected interest rate hike by the Federal Reserve. 聽Fed Chair Janet Yellen is to hold what will be a closely-watched press conference 30 minutes after the release of the Fed's statement, as investors look for fresh hints on the pace of further tightening in the months to come and next year.
 - POPEC sees oil market re-balancing at slower pace, says output rises: OPEC said on Tuesday a long-awaited re balancing of the oil market was under way at a "slower pace" and reported that its own output in May jumped due to gains in nations exempt from a pact to reduce supply. In a monthly report, the Organization of the Petroleum Exporting Countries said its output rose by 336,000 barrels per day (bpd) in May to 32.14 million bpd.

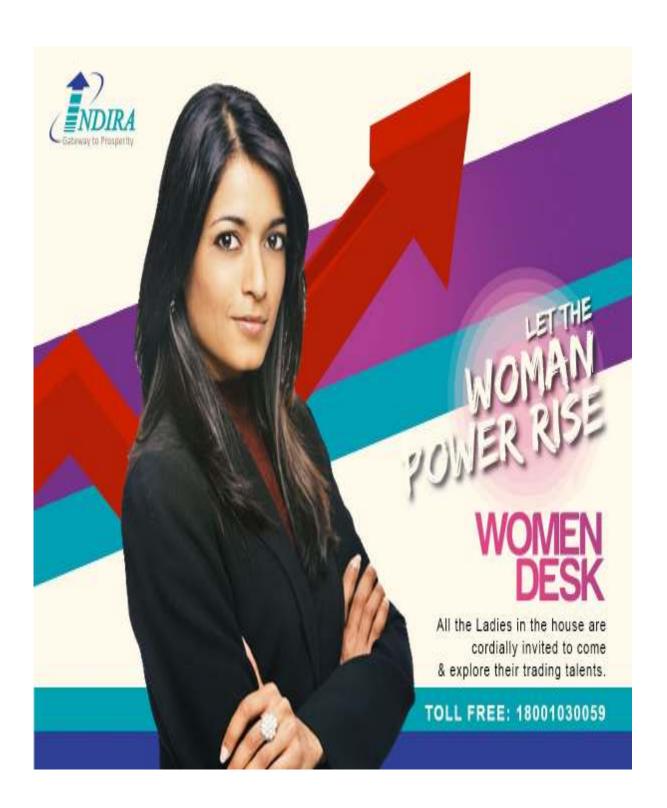
