MARKET COMMENTARY

Nifty closed at 9886 level down by 5 points while Sensex closed at 32020 level down by 16 points on Friday. There were 587 advances, 1086 declines and 288 unchanged stocks on NSE reflecting mixed sentiments floating in the market.

TCS and Infosys contributed most to the losses of major indices in the market. TCS closed at Rs 2397.45 per share, down by Rs 48.95 per share or 2%. Infosys closed at Rs 972.05 per share, down by Rs 5 per share or 0.5%.

BSE Mid-cap index closed at 15187 level, up by 33 points or 0.22% and BSE Small-cap index closed at 15908 level, down by 55 points or 0.35%.

 - ➤ Dollar sinks to 10-month low on weak inflation and retail sales data:

 The dollar slumped to a 10-month low against a basket of global currencies on Friday, after a duo of economic reports showed a slowdown in inflation and retail sales, pointing to weakness in the U.S. economy. The U.S. dollar index, which measures the greenback's strength against a trade-weighted basket of six major currencies, fell by

0.54% to 95.04.

Oil on track for weekly gains ahead of rig count: - Oil was firm Friday remaining on track for weekly gains of about 5% as the latest U.S. rig count is awaited. The market was underpinned this week by a big draw in U.S. crude inventories. On the negative side, OPEC compliance with agreed output cuts fell to its lowest level in six months in June. OPEC and non-OPEC producers have agreed to curb output by 1.8 million barrels a day through to March. OPEC output also increased in June as Libya and Nigeria raised production.


