MARKET COMMENTARY

Major indices in the market ended near 2-week closing low on Monday. Nifty closed at 9,754 level, down by 83 points while Sensex closed at 31,258 level, down by 265 points. There were 521 advances, 1,161 declines and 287 unchanged stocks on NSE reflecting strong negative sentiments floating in the market. India VIX ended at 14.77 level, up by 1.38%.

Infosys posted biggest 2-day fall since April 2013 and closed at Rs 873.4 per share, down by Rs 49.85 per share or 5.4%. The stock contributed the most in Nifty and Sensex losses on Monday.

On the broader markets, BSE Mid-cap index closed at 14,987 level, down by 1.45%. BSE Small-cap index closed at 15,459 level, down by 1.02%.

Bank Nifty closed in negative territory below its 52-day moving average at 23,936 level, down by 137 points or 0.57%. Bank of Baroda was the top loser in the index ended at Rs 142 per share, down by 3.53%. PNB also ended in the red zone, down by 3.2% at Rs 137.6 per share.

 - U.S. Stocks Fall with Dollar as Treasuries Gain: Markets Wrap: -U.S. stocks fell to the lowest level in six weeks amid growing unease about persistent low inflation. Treasuries gained, while the dollar edged lower as investors await central bank speeches at Jackson Hole.
 - Dollar index turns lower, hits 1week trough: - The dollar turned lower and hit a one-week trough against the other major currencies on Monday, as U.S. political tensions continued to weigh heavily on the greenback. Trading volumes were expected to remain light with no major U.S. data to be released throughout the day. Sentiment on the greenback remained vulnerable following news on Friday that senior White House advisor Steven Bannon had been fired. Ongoing uncertainty over the economic agenda of U.S. President Donald Trump and doubts that the Federal Reserve will deliver a third rate hike this year have fed into recent dollar weakness.
 - Gold holds onto gains as geopolitical risks linger: - Gold prices held onto modest gains on Monday, hovering close to a nearly one-year high, as geopolitical tensions continued to support demand for safe-haven assets.
 - ➤ U.S. natural gas futures start the week on upbeat note: U.S. natural gas futures edged higher on Monday, hitting their strongest level in almost a week as near-term weather forecasts turned warmer. Hot high pressure will dominate most of the U.S. in the week ahead, with highs of upper 80s to 100s to drive considerably stronger than normal national demand.
