# **MARKET COMMENTARY**

Nifty ended at 9,912 level, up by 55 points while Sensex ended at 31,750 level, up by 154 points in Monday's trading session. Nifty could end above 9,900 level after five trading sessions. There were 1,097 advances, 555 declines and 323 unchanged stocks on NSE reflecting strong positive undertone floating in the market.

Infosys was top Nifty gainer to close at Rs 941 per share, up by 3.16%. The stock witnessed trading volume of 2,03,41,113 shares and traded value of Rs 1921.86 crore in today's trading session. On the broader markets, BSE Mid-cap index ended at 15,407 level, up by 1.02% while BSE Small-cap index ended at 15,814 level, up by 1.07%

Bank Nifty closed at 24,377 level, up by 102 points or 0.42% on Monday. Federal Bank was top gainer in the index closed at Rs 109.7 per share, up by 3.05%.

  - Stocks Mixed as Traders Weigh Harvey; Gas Surges: Markets Wrap:
    - U.S. stocks were little changed, the dollar struggled and gold rose as investors weighed the damage from Tropical Storm Harvey. European stocks started the week on the back foot following Friday's euro surge, but managed to pare a drop.
  - Dollar extends drop in wake of Yellen, Draghi comments: - The U.S. dollar dropped to its lowest in roughly 16 months against a basket of major currencies and a more than 2-1/2-year low against the euro on Monday, following comments from central bankers on Friday and worries over Tropical Storm Harvey. The greenback extended losses after tumbling on Friday after U.S. Federal Reserve chair Janet Yellen did not mention monetary policy at a summit of central bankers in Wyoming, moderating expectations the Fed will raise interest rates further this year.
  - ➤ Gold prices remain supported on weaker dollar: Gold prices continued to hover near a two-month peak on Monday, as Federal Reserve Chair Janet Yellen's disappointing remarks at the Jackson Hole summit continued to weigh heavily on the greenback.
  - ➤ Crude oil prices sink while gasoline soars: While Hurricane Harvey sends gasoline futures prices soaring, U.S. crude oil -2.5% at \$46.67 in volatile trading as diminished supply is more than offset by the hit to demand for crude by refinery shutdowns.
