# **MARKET COMMENTARY**

Key benchmark indices ended a volatile trading session with small gains. The barometer index, the S&P BSE Sensex, rose 55.52 points or 0.17% to settle at 32,241.93. The Nifty 50 index advanced 7.30 points or 0.07% to settle at 10,086.60. The Sensex has risen for the sixth straight session.

Key indices opened the session with modest gains tracking overnight gains on Wall Street. Later, indices trimmed gains to trade with small gains till mid-afternoon trade. Indices closed the session with small gains amid slight volatility in the late trade.

The Sensex rose 55.52 points or 0.17% to settle at 32,241.93, its highest closing level since 7 August 2017. It rose 142.20 points, or 0.44% at the day's high of 32,328.61. It advanced 0.43 points at the day's low of 32,186.84.

The Nifty advanced 7.30 points or 0.07% to settle at 10,086.60, its highest closing level since 12 September 2017. It rose 47.20 points, or 0.47% at the day's high of 10,126.50. It fell 8.95 points, or 0.09% at the day's low of 10,070.35.

The breadth, indicating the overall health of the market, was positive. On BSE, 1,313 shares rose and 1,307 shares fell. A total of 148 shares were unchanged.
