MARKET COMMENTARY

Nifty ended at 9,768 level, up by 33 points, while Sensex closed at 31,282 level, up by 122 points on Thursday. There were 998 advances, 631 declines and 335 unchanged stocks on NSE. India VIX ended lower by 4.34% at 13.26 level.

In the broader markets, BSE Mid-cap index closed at 15,302 level, up by 110 points, while BSE Small-cap index closed at 15,946 level, up by 148 points. Bank Nifty ended at 24,031 level, up by 218 points or 0.92%.

All the sectoral indices on NSE closed in the positive territory except IT and media. Nifty Realty index was the top gaining index ending at 266.75 level, up by 1.21%. Nifty IT index ended lower by 0.27% at 10,515 level.

Kotak Bank was top gainer in the Bank Nifty index gaining Rs 26.5 per share or 2.71% at Rs 1,006.1 per share. HDFC Bank and State Bank of India were also among top gainers in the index ended higher by more than 1%.

 - > Stocks Mixed as Bonds, Dollar Slump on Tax Plan: Markets Wrap: U.S. stocks were little changed as they headed for an eighth straight quarterly gain, while the dollar slipped with Treasuries as investors assessed the implications of Donald Trump's tax proposal. Oil climbed into a bull market.
 - ▶ Dollar Slides Vs. Rivals but Remains Close to 1-Month Peak: - The dollar remained lower against other major currencies on Thursday, after the release of mixed U.S. data, but it was still close to a one-month peak amid hopes for an upcoming U.S. tax overhaul and for a December rate hike by the Federal Reserve. Data on Thursday showed that U.S. economic growth in the second quarter was revised up more than expected. Separately, the U.S. Department of Labor said initial jobless claims increased more than expected last week.
 - ➢ Gold Prices Little Changed after Mixed U.S. Data: - Gold prices were little changed near one-and-a-half month lows on Thursday, after the release of mixed U.S. economic reports and as the greenback was still broadly supported.
 - Turkey raises oil threat after Iraqi Kurds back independence: - Turkey threatened potentially crippling restrictions on oil trading with Iraqi Kurds on Thursday after they backed independence from Baghdad in a referendum that has alarmed Ankara as it faces a separatist insurgency from its own Kurdish minority.
