MARKET COMMENTARY

The Nifty 50 index surged 111.60 points or 1.12% to settle at 10,096.40, its highest closing level since 21 September 2017. The Nifty rose 119.65 points, or 1.20% at the day's high of 10,104.45 in late trade. The index fell 7.70 points, or 0.08% at the day's low of 9,977.10 in early trade.

Sensex surged 348.23 points or 1.09% to settle at 32,182.22, its highest closing level since 21 September 2017. The Sensex rose 375.04 points, or 1.18% at the day's high of 32,209.03 in late trade. The index fell 20.32 points, or 0.06% at the day's low of 31,813.67 in early trade.

The market breadth, indicating the overall health of the market, was strong. On BSE, 1,706 shares rose and 962 shares fell. A total of 130 shares were unchanged.

Among the sectoral indices on BSE, the S&P BSE Energy index (up 1.95%), the BSE FMCG index (up 1.18%), the BSE Realty index (up 1.49%) and the BSE Metal index (up 1.9%) outperformed the Sensex. The BSE Finance index (up 0.96%), the BSE IT index (up 0.68%), the BSE Utilities index (up 0.76%) and the BSE Capital Goods index (up 0.9%) underperformed the Sensex.

 greenback strengthened after the U.S.
 Department of Labor reported on
 Thursday that initial jobless claims fell
 more than expected to 243,000 last
 weeks.
 - Crude Oil Prices Trim Losses after Drop in U.S. Stockpiles: - Oil prices trimmed losses on Thursday, after data from the U.S. Energy Information Administration showed that domestic crude stockpiles fell more than expected last week.
 - ➢ Gold Prices Trim Gains but Remain Near 2-Week Peak: - Gold prices trimmed gains on Thursday, as a string of upbeat U.S. economic reports lent some support to a weakened dollar, although caution ahead of Friday's U.S. inflation data was expected to limit the greenback's gains. The data came a day after the minutes of the Federal Reserve's September policy meeting showed that policymakers remain divided_on_inflation.

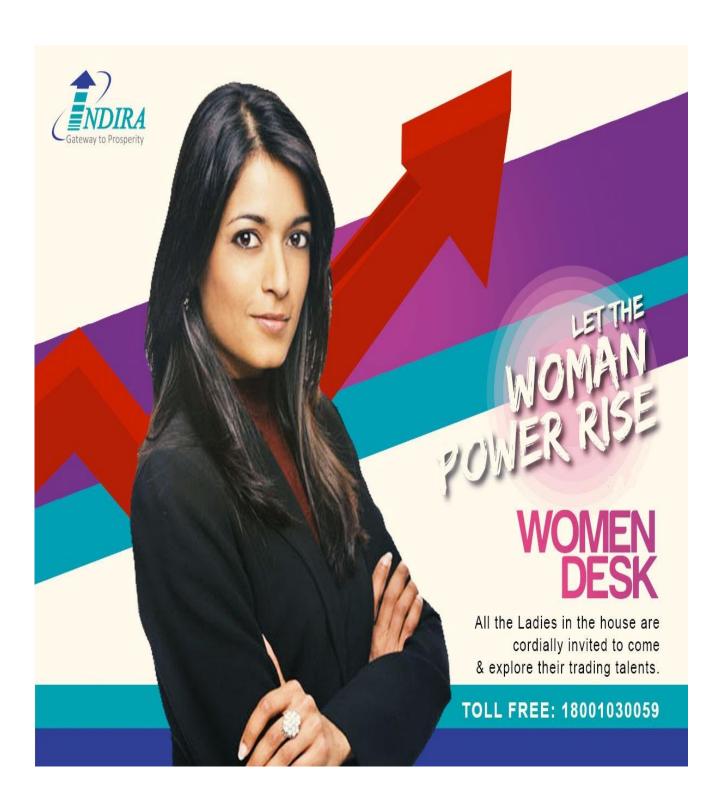
