MARKET COMMENTARY

Nifty advanced 48.45 points or 0.47% to settle at 10,343.80, its record closing high. The index rose 60.30 points or 0.58% at the day's high of 10,355.65 in late trade. The index declined 23.50 points or 0.22% at the day's low of 10,271.85.

Sensex rose 104.63 points or 0.32% to settle at 33,147.13, its record closing high. The index gained 108.76 points or 0.33% at the day's high of 33,151.26. The index fell 207.44 points or 0.62% at the day's low of 32,835.06.

Indicating the overall health of the market, was positive. On the BSE, 1,375 shares rose and 1,326 shares declined. A total of 149 shares were unchanged.

The total turnover on BSE amounted to Rs 5127.77 crore, lower than turnover of Rs 6014.32 crore registered during the previous trading session.

 - ➤ U.S. Stocks Rise on Strong Earnings, Euro Falls: Markets Wrap: - U.S. stock indexes climbed amid a raft of robust earnings reports and speculation about the Federal Reserve's next leader. The euro fell after the European Central Bank met market expectations for reducing its bond purchase program.
 - Program: The Euro slumped against the dollar on Thursday after the European Central Bank said it would slow down its asset purchasing program in January. The ECB will reduce monthly purchases from the current €60 billion (\$70.6 billion) to €30 billion (\$35.3 billion) and will extend those purchases to "the end of September 2018, or beyond, if necessary". The central bank also left the benchmark interest rate unchanged at 0.0%.
 - China says again it will keep yuan exchange rate basically stable: -China's foreign exchange regulator reiterated on Thursday that it will keep the yuan exchange rate basically stable and will deepen market-based exchange rate reform.
 - ➤ Oil Prices Slip Further Following Surprise U.S. Crude Build: - Crude oil prices edged lower on Thursday, after data from the U.S. Energy Information Administration showed domestic crude stockpiles increased for the first time in five weeks.
 - ➤ U.S. Natural Gas Futures Pare
 Losses After Storage Data: U.S.
 natural gas futures initially pared losses
 in North American trade on Thursday,
 after data showed that natural gas
 supplies in storage in the U.S. rose
 slightly less than expected last week.

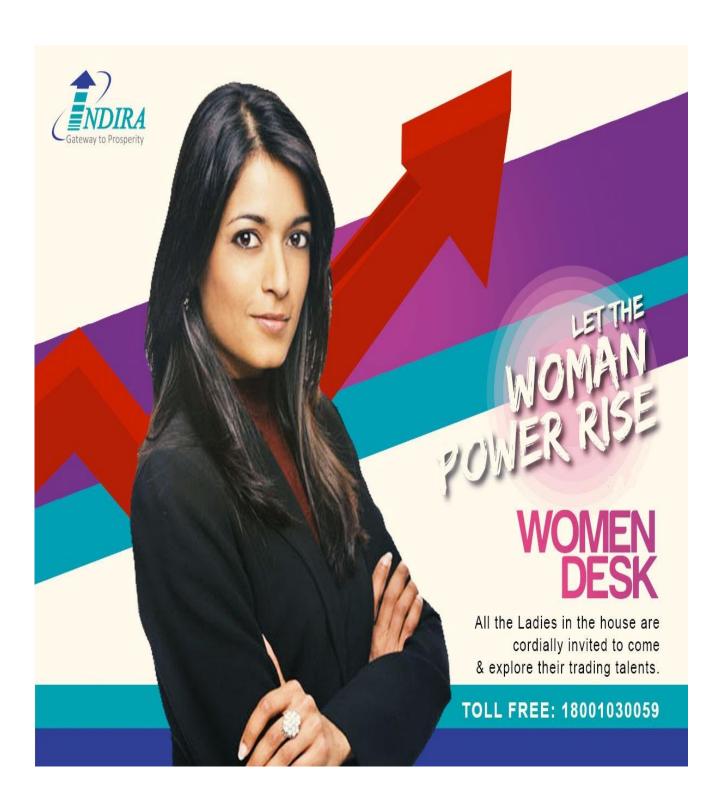
