MARKET COMMENTARY

Nifty rose 40.60 points or 0.39% to settle at 10,363.65, a record closing high. The index rose 61.45 points, or 0.6% at the day's high of 10,384.50, its record high level. The index rose 21.25 points, or 0.21% at the day's low of 10,344.30.

Sensex rose 108.94 points or 0.33% to settle at 33,266.16, a record closing high. The index rose 182.95 points, or 0.55% at the day's high of 33,340.17, its record high level. The index rose 49.71 points, or 0.15% at the day's low of 33,206.93

The total turnover on BSE amounted to Rs 4279.33 crore, lower than turnover of Rs 5595.40 crore registered during the previous trading session.

The market breadth, indicating the overall health of the market, was strong. On BSE, 1,750 shares rose and 1,013 shares fell. A total of 175 shares were unchanged.

Crude prices rallied last week after Saudi Arabian Crown Prince Mohammed bin Salman indicated that the top oil exporter needed to extend production cuts in order to stabilize markets, suggesting an agreement for another nine-month extension through the end of next year.

 - Natural gas futures started the week on a downbeat note on Monday, as traders reacted to bearish weather forecasts for most parts of the United States over the next two weeks, that should lead to a dip in heating demand.
