The Sensex fell 281 points or 0.84% to settle at 33,033.56, its lowest closing level since 24 October 2017. The index rose 102.74 points, or 0.31% at the day's high of 33,417.3. The index fell 314.58 points, or 0.94% at the day's low of 32,999.98.

The Nifty 50 index fell 96.80 points or 0.94% to settle at 10,224.95, its lowest closing level since 24 October 2017. The index rose 12.40 points, or 0.12% at the day's high of 10,334.15. The index fell 105.50 points, or 1.02% at the day's low of 10,216.25.

mong secondary indices, the S&P BSE Mid-Cap index fell 0.19%. The S&P BSE Small-Cap index declined 0.41%. The losses for both the indices were lower than the Sensex's slide in percentage terms.

 - Stocks Decline as Bonds Gain; Pound Under Pressure: Markets Wrap: - U.S. stocks joined declines in global equities, while Treasuries and the dollar climbed as a risk-off tone spread across markets. The pound weakened amid renewed political pressure on U.K. Prime Minister Theresa May.
 - ➤ It looks like a busy week for investors. U.S. inflation and growth numbers are on the docket, and they could be key to the Federal Reserve's determination to lift rates next month. Talks on American tax legislation may also play into market thinking; pessimism over the likelihood of successful reforms helped drag global equities down from this month's record high late last week. Measures of equitymarket volatility have risen, albeit from low levels.
 - ▶ OPEC points to larger 2018 oil supply deficit as market tightens: LONDON (Reuters) OPEC raised its forecast on Monday for demand for its oil in 2018 and said its deal with other producers to cut output was reducing excess oil in storage, potentially pushing the global market into a larger deficit next year. The Organization of the Petroleum Exporting Countries also said in a monthly report it had cut its estimate of 2018 supply from non-OPEC producers and said oil use would grow faster than previously thought due to a stronger-than-expected world economy.
 - ➢ Gold Holds onto Gains Amid U.S. Tax Reform Uncertainty: - Gold held onto gains on Monday, as ongoing uncertainty over the fate of a major U.S. tax reform bill continued to dampen demand for the dollar.


