

MARKET COMMENTARY

The Sensex rose 346.38 points or 1.06% to settle at 33,106.82, its highest closing level since 10 November 2017. The index rose 404.71 points, or 1.24% at the day's high of 33,165.15. The index rose 69.38 points, or 0.21% at the day's low of 32,829.82.

The Nifty 50 index rose 96.70 points or 0.96% to settle at 10,214.75, its highest closing level since 13 November 2017. The index rose 114.20 points, or 1.13% at the day's high of 10,232.25. The index rose 21.15 points, or 0.21% at the day's low of 10,139.20

S&P BSE Mid-Cap index rose 1.07%. The S&P BSE Small-Cap index advanced 1.10%. Both the indices underperformed the Sensex.

On BSE, 1,683 shares rose and 982 shares declined. A total of 159 shares were unchanged. Nifty likely to trade in the range of 10009-10381.

 - ▶ U.S. Stocks Rebound as Treasuries, Dollar Decline: Markets Wrap: - U.S. stocks rebounded after European and Asian counterparts climbed, while Treasuries fell as the global risk-off mood eased. The dollar dipped as the pound and the loonie edged higher.
 - ➤ Forex Dollar Holding Above 1-Month Lows before U.S. Tax Vote: -The dollar was holding above one-month lows against a basket of the other major currencies on Thursday as investors awaited a vote on the U.S. tax bill later in the day.
 - Crude Oil Still Under Pressure on **U.S. Stockpile Rise**: - Crude oil prices remained under pressure on Thursday, as news of an unexpected increase in U.S. crude inventories overshadowed hopes that oil producers will extend their deal to reduce output. Prices came under pressure after the EIA reported on Wednesday that crude oil inventories rose by 1.9 million barrels last week, marking the second-straight increase and compared with analysts' expectations for a decline of 2.2 million barrels. Oil prices had been supported in recent weeks by optimism that oil producing countries will agree to extend an output cut at their meeting at the end of this month.

 Data, Eyes on Tax Vote: Gold prices moved higher on Thursday, after the release of disappointing U.S. jobless claims data and manufacturing activity data dented demand for the greenback and as investors remained cautious ahead of a highly-anticipated vote on a major U.S. tax reform plan.
