

## **MARKET COMMENTARY**

The Nifty rose 28.15 points or 0.27% to settle at 10,326.90, its highest closing level since 7 November 2017. The index gained 59.95 points or 0.58% at the day's high of 10,358.70. The index rose 16.30 points or 0.16% at the day's low of 10,315.05.

The Sensex advanced 118.45 points or 0.36% to settle at 33,478.35, its highest closing level since 6 November 2017. The index gained 265.15 points or 0.79% at the day's high of 33,625.05. The index gained 77.71 points or 0.23% at the day's low of 33,437.61.

The S&P BSE Mid-Cap index rose 0.1%, underperforming the Sensex. The S&P BSE Small-Cap index advanced 0.37%, outperforming the Sensex.

The total turnover on BSE amounted to Rs 4822.95 crore, higher than turnover of Rs 3572.36 crore registered during the previous trading session. N

  - ➤ U.S. Stocks Head for Second Straight Day of Gains: Markets Wrap: U.S. stocks pushed higher for the second day this week, while bonds across Europe followed a rise in Treasuries after the European Central Bank was said to be likely to make only small adjustments to its guidance on monetary policy next year.
  - Forex Dollar Hovering Near 1-Week Highs, Euro Slips: - The dollar was hovering near one-week highs against a basket of the other major currencies on Tuesday, while the euro remained under pressure amid ongoing concerns over political deadlock in Germany.
  - ➢ Gold Prices Hold onto Gains on Softer Dollar:
     Gold prices held onto gains on Tuesday, as sentiment on the U.S. dollar remained fragile amid ongoing uncertainty over the fate of a U.S. tax bill and ahead of the minutes of the Federal Reserve's policy meeting due on Wednesday. The House of Representatives passed a bill last week that would lower corporate taxes and cut individual taxes for most households in 2018.
  - ➤ Natural Gas Futures Slide Further to Reach 3-Week Lows: - Natural gas futures extended losses from the last session to reach its lowest level in around three weeks on Tuesday, amid forecasts for less heating demand over the next two weeks.
  - Crude Oil Prices Remain Moderately Higher in Quiet Trade: - Crude oil prices remained moderately higher in quiet trade on Tuesday, as investors eyed the release of upcoming U.S. inventory reports after news last week of an increase in production dampened optimism over the rebalancing of the market.
