MARKET COMMENTARY

The Sensex rose 26.53 points or 0.08% to settle at 33,588.08, its highest closing level since 6 November 2017. The index gained 108.64 points, or 0.32%, at the day's high of 33,670.19. The index fell 93.25 points, or 0.28%, at the day's low of 33,468.30.

The Nifty gained 6.45 points or 0.06% to settle at 10,348.75. its highest closing level since 7 November 2017. The index gained 32 points, or 0.31%, at the day's high of 10,374.30. The index shed 35 points, or 0.33%, at the day's low of 10,307.30.

Among secondary indices, the S&P BSE Mid-Cap index rose 0.3%. The S&P BSE Small-Cap index advanced 0.51%. Both theses indices outperformed the Sensex.

The breadth, indicating the overall health of the market, was positive. On BSE, 1,443 shares rose and 1,254 shares declined. A total of 158 shares were unchanged.

 - European Stocks Erase Losses;Dollar Extends Drop: Markets Wrap:
 - European stocks erased early losses as positive economic data in the region offset negative sentiment following a slump in Chinese equities. The dollar extended a retreat, but at a slower pace than in the wake of Wednesday's more dovish than expected Federal Reserve minutes.
 - Forex Dollar Slips to 5-Week Lows in Holiday-Thinned Trade: The dollar slid to five-week lows against a basket of the other major currencies on Thursday amid concerns over sluggish U.S. inflation as trade volumes remained thin with U.S. markets staying closed for the Thanksgiving Holiday. The dollar remained on the defensive after the minutes of the Federal Reserve's November meeting showed that some officials were concerned inflation would stay below the bank's 2% target for longer than expected.
 - Federal Reserve's most recent policy meeting pushed the U.S. dollar, lending support to the precious metal.
