MARKET COMMENTARY

The Sensex lost 205.26 points or 0.63% to settle at 32,597.18, its lowest closing level since 23 October 2017. The Sensex rose 2.31 points, or 0.01% at the day's high of 32,804.75 in morning trade. The index fell 237.28 points, or 0.72% at the day's low of 32,565.16 in mid-afternoon trade.

The Nifty lost 74.15 points or 0.73% to settle at 10,044.10, its lowest closing level since 11 October 2017. The Nifty fell 14.05 points, or 0.14% at the day's high of 10,104.20 in morning trade. The index fell 84.90 points, or 0.84% at the day's low of 10,033.35 in mid-afternoon trade.

Among secondary barometers, the BSE Mid-Cap index fell 0.89%. The BSE Small-Cap index fell 0.66%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was weak. On BSE, 1,644 shares fell and 978 shares rose. A total of 177 shares were unchanged.

 - ▶ U.S. Stocks Fluctuate as Risk-Off Mood Lifts Bonds: Markets Wrap: -U.S. stocks fluctuated after European and Asian shares sank amid a broad risk-off mood. Treasuries climbed with the dollar as investors' focus turned to efforts to avert a U.S. government shutdown Saturday.
 - Dollar Holds onto Gains, U.S. Jobs
 Data Supports: The dollar remained higher against other major counterparts on Wednesday, helped by the release of upbeat U.S. employment data. The greenback strengthened after data showed that the U.S. private sector added 190,000 jobs in November. The dollar was already supported since the U.S. Senate passed a tax overhaul package over the weekend amid expectations that tax cuts for corporations will stimulate the U.S. economy.
 - ▶ Oil Stays Lower as U.S. Fuel Stocks Rise More Than Forecast: - Crude prices stayed lower on Wednesday, after data showed a sizable gain in U.S. gasoline stockpiles. The U.S. Energy Information Administration said in its weekly report that gasoline inventories increased by 6.8 million barrels in the week ended Dec. 1., much higher than expectations for a gain of 1.7 million barrels. For distillate inventories including diesel, the EIA reported a gain of 1.7 million barrels.
 - Natural Gas Futures Rise for First Time in Three Days: - Natural gas futures were higher for the first time in three sessions on Wednesday, as market players continued to monitor winter weather forecasts to gauge demand for the fuel.
