MARKET COMMENTARY

The Sensex advanced 216.27 points or 0.65% to settle at 33,462.97, its highest closing level since 29 November 2017. The Sensex surged 375.26 points, or 1.12%, at the day's high of 33,621.96. The index rose 159.12 points, or 0.47%, at the day's low of 33,405.82.

The Nifty rose 81.15 points or 0.79% to settle at 10,333.25, its highest closing level since 29 November 2017. The Nifty advanced 121 points, or 1.18%, at the day's high of 10,373.10. The index rose 67.55 points, or 0.65%, at the day's low of 10,319.65.

The S&P BSE Mid-Cap index rose 1%. The S&P BSE Small-Cap index advanced 1.38%. Both the indices outperformed the Sensex.

The breadth, indicating the overall health of the market, was strong. On the BSE, 1,612 shares rose and 1,041 shares declined. A total of 164 shares were unchanged.

 - Dollar Bounces Higher but Upside **Seen Limited**: - The dollar bounced higher against other major currencies on Friday, but gains were expected to remain limited by downbeat U.S. data and fresh concerns over U.S. tax reform plans. Data on Friday showed that both U.S. industrial and manufacturing production rose less than expected in November. The report came shortly after the New York Federal Reserve said its Empire State manufacturing index fell to 18.0 in December from 19.4 the previous month, confounding expectations for a reading of 18.6. The greenback had come under pressure after two U.S. Republican senators on Thursday sought changes to the proposed U.S. tax reform bill. The bill needs a simple majority to pass in the Senate, in which Republicans hold just 52 of the 100 seats.
 - Oil prices edge up on North Sea pipeline outage, falling stocks: - Oil prices edged up on Friday, lifted by the Forties pipeline outage in the North Sea, ongoing OPEC-led production cuts and a decline in global stocks, although rising U.S. output kept a lid on markets.
