MARKET COMMENTARY

The Sensex gained 235.06 points, or 0.7%, to settle at 33,836.74, a record high. The index gained 260.39 points or 0.77% at the day's high of 33,862.07. The index rose 64.94 points or 0.19% at the day's low of 33,666.62.

The Nifty rose 74.45 points, or 0.72%, to settle at 10,463.20, a record high. The index gained 83.45 points or 0.8% at the day's high of 10,472.20. The index rose 17.25 points or 0.17% at the day's low of 10,406.

Among secondary indices, the S&P BSE Mid-Cap index rose 1.47%. The S&P BSE Small-Cap index gained 1.51%. Both these indices outperformed the Sensex.

The broad market depicted strength. There were more than two gainers for every loser on BSE. 1,890 shares rose and 789 shares fell. A total of 164 shares were unchanged.

Nifty likely to trade in the range of 9792-10900.

 - ➤ U.S. Stocks Drop as Investors Await Tax-Cut Vote: Markets Wrap: U.S. equity markets fell as investors waited for lawmakers to vote on tax cuts in the world's largest economy. Treasuries declined while the dollar rose.
 - Dollar Remains Moderately Lower **Despite Upbeat U.S. Data**: - The dollar remained moderately lower against other major's currencies on Tuesday, despite the release of upbeat U.S. data, as investors remained cautious regarding progress on the U.S. tax reform front. Trading volumes were expected to become more and more thin throughout the week, ahead of the Christmas holiday. The dollar shrugged off data on Tuesday showing that the number of U.S. housing starts unexpectedly increased in November, while building permits declined much less than expected.
 - ➢ Gold Prices Down Slightly in Asia with Holiday Range Trade in Place: Gold prices eased slightly in Asia on Tuesday with the market in a preholiday lull and awaiting a Bank of Japan policy review to conclude on Wednesday and a US tax cut package expected to pass this week. Overnight, gold prices rose on Monday, buoyed by dollar weakness on tax reform jitters despite reports suggesting Republicans lawmakers could vote on the final tax bill as soon as Tuesday.
 - ➤ Crude Oil Prices Edge Higher but
 Upside Limited: Crude oil prices
 edged higher on Tuesday, supported by
 ongoing supply disruptions in the North
 Sea, although concerns over rising U.S.
 production levels continued to limit
 gains.
