

MARKET COMMENTARY

The Sensex fell 63.78 points or 0.19% to settle at 33,848.03, its lowest closing level since 21 December 2017. The index gained 111.84 points or 0.33% at the day's high of 34,023.65. The index fell 159.78 points or 0.47% at the day's low of 33,752.03.

The Nifty lost 12.85 points or 0.12% to settle at 10,477.90, its lowest closing level since 21 December 2017. The index gained 43.80 points or 0.42% at the day's high of 10,534.55. The index fell 30.30 points or 0.29% at the day's low of 10,460.45.

Among secondary indices, the S&P BSE Mid-Cap index rose 0.1%. The S&P BSE Small-Cap index gained 0.32%. Both these indices outperformed the Sensex.

The breadth, indicating the overall health of the market, was positive. On the BSE, 1,458 shares rose and 1,302 shares fell. A total of 197 shares were unchanged.

 - ➤ Greenback, Treasuries Decline as Stocks Fluctuate: Markets Wrap: -The dollar fell to its lowest level this month, while Treasury yields rose after Wednesday's slide. U.S. stocks fluctuated amid thinned-out trading between holidays.
 - Forex- Dollar Continues to Fall in **Holiday Lull**: - The dollar fell against other major currencies on Thursday as the holiday lull continues. Trading volumes are expected to remain thin during the last week of the year. The greenback fell for the third consecutive day, nearing a three-month low. Some analysts think the weakness is due to sell offs after President Donald Trump signed the tax bill into law. The dollar also failed to move on news that initial jobless claims remained steady last week. The number of individuals filing for initial jobless benefits in the week ending Dec. 22 was flat at a seasonally adjusted 245,000, the Department of Labor said on Thursday.

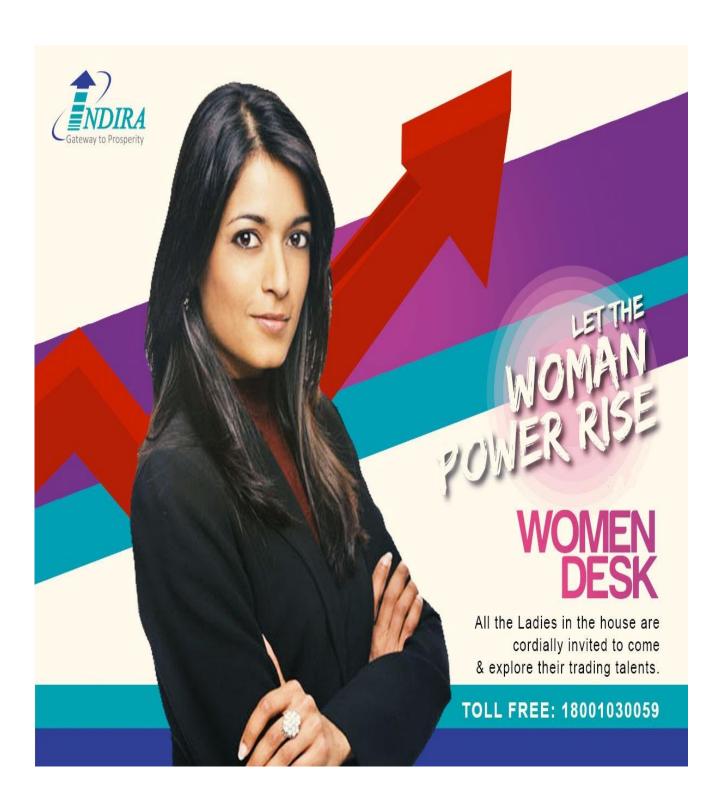
