# **MARKET COMMENTARY**

The Sensex rose 90.40 points or 0.26% to settle at 34,443.19, its record closing high. The index rose 135.24 points, or 0.39% at the day's high of 34,488.03, a record high. The index fell 9.38 points, or 0.03% at the day's low of 34,343.41.

The Nifty 50 index rose 13.40 points or 0.13% to settle at 10,637, its record closing high. The index rose 35.55 points, or 0.33% at the day's high of 10,659.15, a record high. The index fell 20 points, or 0.19% at the day's low of 10,603.60.

Among secondary indices, the S&P BSE Mid-Cap index fell 0.40%. The S&P BSE Small-Cap index advanced 0.08%. Both these indices underperformed the Sensex.

The breadth, indicating the overall health of the market, was negative. On the BSE, 1,623 shares fell and 1,369 shares rose. A total of 102 shares were unchanged.

  - ▶ U.S. Stocks at Records as Dollar Gains, Bonds Fall: Markets Wrap: -U.S. stocks padded all-time highs before the start of earnings season, while the dollar got a boost from policy steps in Asia that propelled Treasury yields to the highest level in nine months.
  - Forex Yen Higher as BOJ Tweaks Bond Purchases, Euro Slides: - The yen was broadly higher on Tuesday after the Bank of Japan trimmed the size of its bond purchases, while the euro retreated further from last week's multimonth highs. The yen strengthened after the BOJ trimmed the size of its bond-repurchase offer by 5% in its latest market operation, sparking speculation that it may slow its monetary stimulus later this year. The fall in the euro came as investors took profits after its recent rally amid concerns that the European Central Bank may attempt to talk down the strengthening currency ahead of its monetary policy meeting later this month.
  - ➤ Gold Prices Remain Lower on Stronger U.S. Dollar: - Gold prices remained lower on Tuesday, as expectations for upcoming rate hikes by the Federal Reserve continued to support to the dollar.
  - ▶ Crude Oil Prices Continue to Rise as Optimism Dominates: - Crude oil prices continued to rise and were trading near multi-year highs on Tuesday, as a decline in U.S. oil rigs and supply cuts by major oil producers continued to support the commodity. Oil prices remained supported since after Baker Hughes on Friday reported a decline by five to 742 in the number of U.S. rigs in the week to January 5.


