MARKET COMMENTARY

The Sensex fell 144.52 points or 0.42% to settle at 34,155.95, its lowest closing level since 9 February 2018. The index gained 172.96 points, or 0.5%, at the day's high of 34,473.43. The index skidded 271.79 points, or 0.79%, at the day's low of 34,028.68.

The Nifty slipped 38.85 points or 0.37% to settle at 10,500.90, its lowest closing level since 9 February 2018. The index gained 50.80 points, or 0.48%, at the day's high of 10,590.55. The index fell 83.10 points, or 0.79%, at the day's low of 10,456.65.

Among secondary indices, the S&P BSE Mid-Cap index rose 0.17%. The S&P BSE Small-Cap index gained 0.16%. Both these indices outperformed the Sensex.

The breadth, indicating the overall health of the market, was negative. On the BSE, 1,479 shares declined and 1,351 shares advanced. A total of 134 shares were unchanged.

 - ➤ U.S.-E.U. Friction Grows Over
 Weakening Dollar: The weakening
 U.S. dollar is causing friction between
 the European Union and the Trump
 administration. There's growing concern
 in Europe that the U.S. is seeking a
 weaker dollar to make American goods
 more competitive abroad. The concern
 comes even after President Trump said
 he wanted a strong dollar following
 controversial comments from Treasury
 Secretary Steve Mnuchin that a weaker
 dollar was good for the U.S. The dollar is
 down about 3% against the euro this
 year, after a double-digit loss in 2017.
 - Natural Gas Futures Slide Back
 Toward 21-Month Lows After Brief
 Reprieve: Natural gas futures were
 under pressure again on Wednesday,
 falling back towards their lowest level in
 almost two years amid speculation the
 end of the winter heating season will
 bring warmer temperatures throughout
 the U.S. and cut into demand for the
 fuel.
 - As U.S. Oil Production Surges, OPEC Stays the Course: Global crude oil demand this year may be higher than OPEC originally estimated, but so is production from non-cartel members such as the U.S. OPEC won't benefit if it remains committed to a 2017 agreement with Russia and other producers to hold back 1.8 million barrels of oil a day from the market.


