# **MARKET COMMENTARY**

The Sensex lost 162.35 points or 0.47% to settle at 34,184.04, its lowest closing level since 23 February 2018. The Sensex fell 43.65 points, or 0.13% at the day's high of 34,302.74 in mid-afternoon trade. The index fell 269.94 points, or 0.79% at the day's low of 34,076.45 in early trade.

The Nifty 50 index lost 61.45 points or 0.58% to settle at 10,492.85, its lowest closing level since 23 February 2018. The Nifty fell 18.80 points, or 0.18% at the day's high of 10,535.50 in mid-afternoon trade. The index fell 92.75 points, or 0.88% at the day's low of 10,461.55 in early trade.

Among secondary barometers, the BSE Mid-Cap index fell 0.23%, underpeforming the Sensex. The BSE Small-Cap index rose 0.21%, outperforming the Sensex.

  - ➤ U.S. Stocks Fluctuate, Oil Weighs on Energy Shares: Markets Wrap: U.S. stocks crept back from their opening highs and remained on track for their worst month in more than two years as oil tumbled after a government report showed expanding inventories and production in what will soon be the world's largest source of crude.

    Treasuries climbed with the dollar.
  - Forex Dollar Builds on Gains, rises to 1-1/2-Month Highs: The dollar built on early gains against a currency basket on Wednesday, rising to a one-and-a-half month high as expectations for faster hikes in U.S. interest rates remained intact despite a raft of soft U.S. economic data. Demand for the dollar continued to be underpinned after Federal Reserve Chairman Jerome Powell said the U.S. economic outlook remains bright, bolstering bets on further Fed rate hikes this year.
  - ➢ Oil Prices Extend Losses After U.S. Crude Stocks Rise More Than Forecast: Crude prices were lower on Wednesday, hitting the lowest levels of the session after data showed a sizable increase in U.S. oil and gasoline stockpiles last week. The U.S. Energy Information Administration said in its weekly report that crude oil inventories increased by 3.0 million barrels in the week ended Feb. 23.
  - ➢ Gold Prices Hold Near 2-1/2 Week Lows on Stronger Dollar: - Gold prices held steady near a two-and-ahalf-week low on Wednesday, as the U.S. dollar remained broadly supported by expectations for several rate hikes by the Federal Reserve this year despite the release of downbeat U.S. economic growth data.

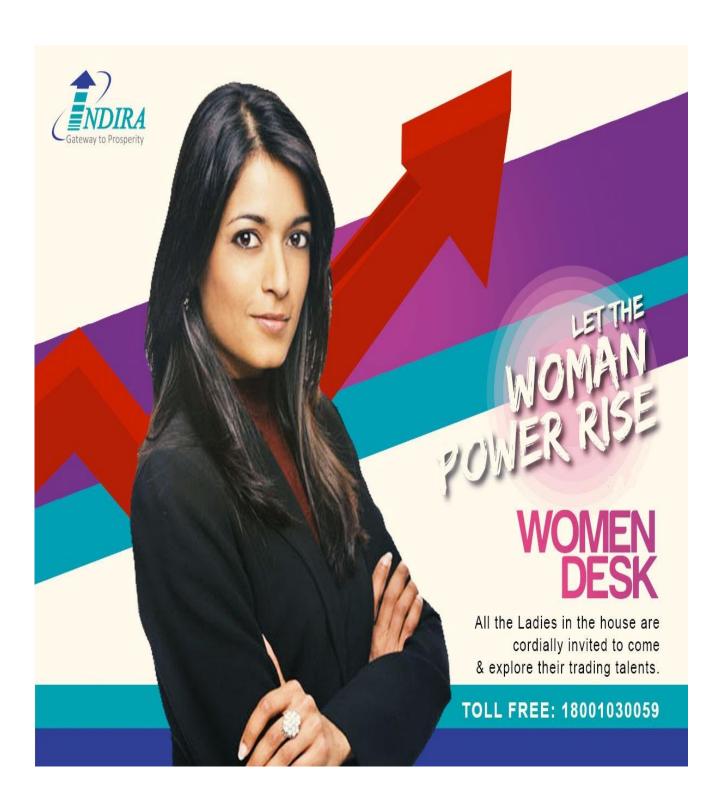
