MARKET COMMENTARY

The Sensex rose 318.48 points or 0.96% to settle at 33,351.57, its highest closing level since 5 March 2018. The index rose 406.88 points, or 1.23% at the day's high of 33,439.97. The index rose 4.39 points, or 0.01% at the day's low of 33,037.48.

The Nifty 50 index rose 88.45 points or 0.87% to settle at 10,242.65, its highest closing level since 6 March 2018. The index rose 116.15 points, or 1.14% at the day's high of 10,270.35. The index fell 7.80 points, or 0.08% at the day's low of 10,146.40.

Among secondary indices, the S&P BSE Mid-Cap index rose 0.56%. The S&P BSE Small-Cap index advanced 0.50%. Both these indices underperformed the Sensex.

The breadth, indicating the overall health of the market, was negative. On the BSE, 1,511 shares declined and 1,202 shares advanced. A total of 153 shares were unchanged.

 - ➤ Stocks Rise as Trade Fears Ebb; Euro Falls on ECB: Markets Wrap: -U.S. stocks and Treasuries rose as investors took solace from suggestions that President Donald Trump's tariff plan will spare select countries. The dollar gained against the euro after the European Central Bank held its key rate and changed its language around stimulus.
 - ▶ Forex Euro Reverses Gains as ECB Downplays Change to QE Pledge: The euro reversed gains on Thursday after European Central Bank President Mario Draghi downplayed a decision to drop a pledge to expand its quantitative easing program from its rate statement. The euro initially rose after the ECB dropped a pledge to extend its stimulus program if necessary from its rate statement, in a sign that it is moving closer to ending its massive monetary stimulus program.
 - Crude Oil Prices Turn Lower as Supply Data Still Weighs: - Crude oil prices turned lower on Thursday, as traders were still digesting the previous session's downbeat U.S. supply data amid sustained fears over a global trade war
 - ➢ Gold Prices Slip Lower Despite U.S. Data: - Gold prices slipped lower on Thursday, as the dollar showed little reaction to downbeat U.S. data amid sustained uncertainty over U.S. President Donald Trump's proposed tariffs.
 - ➤ Natural Gas Futures Continue Lower After Storage Data: The U.S. Energy Information Administration said in its weekly report that natural gas storage in the U.S. fell by 57 billion cubic feet in the week ended March 2.

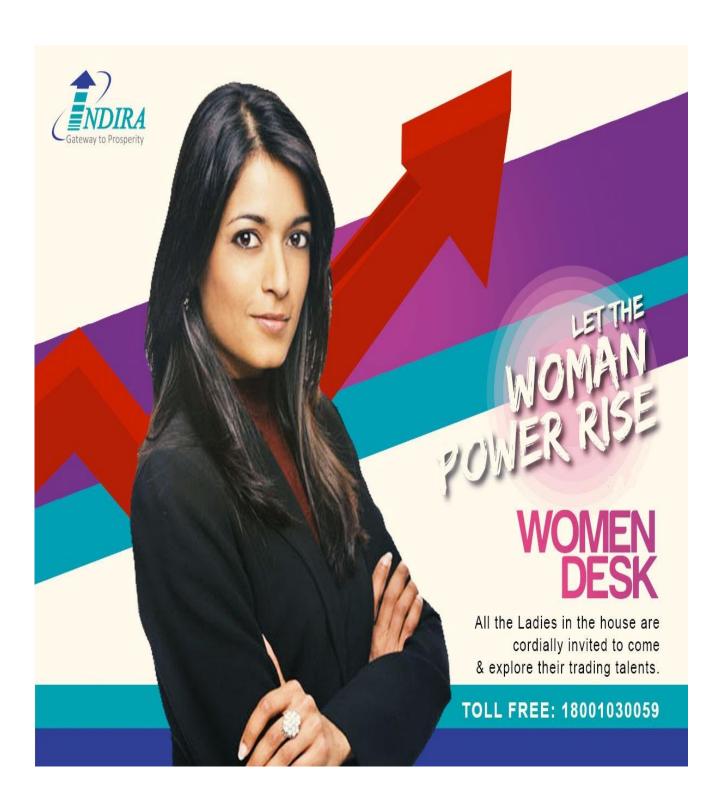
