MARKET COMMENTARY

The Sensex rose 255.94 points, or 0.74% at the day's high of 34,706.71 in late trade. The index rose 14.72 points, or 0.04% at the day's low of 34,465.49 in morning trade.

The Nifty 50 index rose 29.65 points or 0.28% to settle at 10,614.35, its highest closing level since 5 February 2018. The Nifty rose 52.10 points, or 0.49% at the day's high of 10,636.80 in late trade. The index fell 15.70 points, or 0.15% at the day's low of 10,569 in afternoon trade.

Among secondary barometers, the BSE Mid-Cap index fell 0.02%. The BSE Small-Cap index fell 0.13%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was negative. On BSE, 1,480 shares fell and 1,188 shares rose. A total of 149 shares were unchanged.

 - Forex Dollar Pauses as Boost from Treasury Yield Fades: - The dollar took a breather on Tuesday after rising to seven week highs against a basket of the other major currencies, as a boost from rising Treasury yields faded. The dollar had strengthened across the board on Monday as the yield on 10year U.S. Treasury notes hit its highest in more than four years at 2.998%. Yields climbed as strengthening inflation prospects added to expectations for a faster rate of monetary tightening from the Federal Reserve. The yield backed off that level on Tuesday and was last at 2.971%.
 - Oil Prices Break Key Psychological Levels Ahead of Weekly Inventory Data: - Crude prices extended gains in midmorning trade on Tuesday, surpassing key psychological levels, as investors turned their attention toward U.S. weekly supply data.
 - ➢ Gold Rises as U.S. Dollar Falls, 10-Year Treasury Note Reaches 3%: -Gold was higher on Tuesday, as the U.S. dollar fell and U.S. Treasury yields rose. Gold is denominated in the U.S. currency and becomes more expensive for holders of other currencies when the dollar rises.
