MARKET COMMENTARY

The S&P BSE Sensex, lost 187.76 points or 0.53% to settle at 34,915.38, its lowest closing level since 26 April 2018. The Sensex hit high of 35,206.55 and low of 34,847.61 during the day.

The Nifty 50 index fell 61.40 points or 0.57% to settle at 10,618.25, its lowest closing level since 26 April 2018. The Nifty hit high of 10,700.45 and low of 10,601.60 during the day.

The S&P BSE Mid-Cap index fell 0.35%. The S&P BSE Small-Cap index fell 0.25%. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was negative. On the BSE, 1,580 shares fell and 1,115 shares rose. A total of 130 shares were unchanged.

 - ➤ U.S. Stocks Rally After Jobless Rate Sinks to 3.9%: Markets Wrap: U.S. stocks recovered from early-session losses after testing a key technical level, as investors weighed an April U.S. jobs report that showed an 18-year low in the unemployment rate. Treasuries pared gains as the market also assessed the impact of America's trade talks with China. The dollar resumed its climb.
 - Forex Dollar Hits Fresh 4-Month High After Mixed Jobs Report: The dollar marked a fresh four-month high against major rivals on Friday after the release of the monthly nonfarm payrolls. The move higher came after a mixed jobs report that showed fewer jobs were created in April than expected, but the unemployment rate fell to 3.9%, its lowest level since December 2000. Wage inflation remained subdued with a 2.6% rise year-on-year, missing expectations for a gain of 2.7%.
 - Oil turns higher as dollar moves, looming decision on Iran sanctions tug at market: - Oil prices turned higher Friday, consolidating recent action and headed for a weekly gain, as global supplies remain tight and the market looks for possible new sanctions against Iran. Earlier, a stronger dollar was credited with driving down the U.S.based crude contract.
 - ➤ Gold edges lower, heads for first weekly loss in three after jobs report's mixed tone: Gold futures edged lower after a mixed start Friday, heading for their first weekly loss in three weeks, as investors showed a lukewarm reaction to the monthly U.S. jobs report. The data came in a bit softer than expected in some areas.

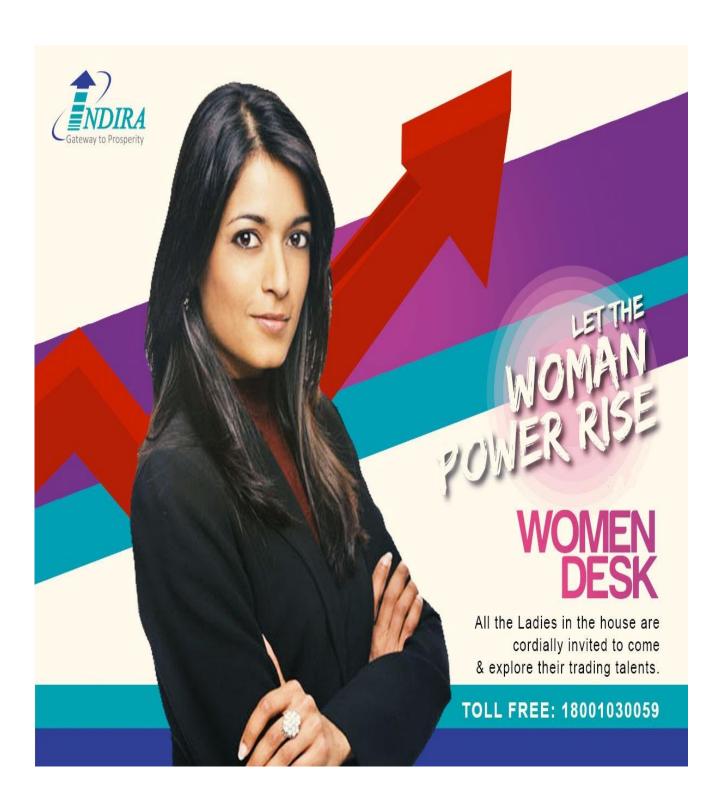
