# **MARKET COMMENTARY**

The S&P BSE Sensex, lost 300.82 points or 0.86% to settle at 34,848.30, its lowest closing level since 26 April 2018. The index hit high of 35,163.11 and low of 34,821.62 during the day.

The Nifty 50 index lost 86.30 points or 0.81% to settle at 10,596.40, its lowest closing level since 25 April 2018. The index hit high of 10,674.95 and low of 10,589.10 during the day.

The S&P BSE Mid-Cap index lost 1.47%. The S&P BSE Small-Cap index lost 1.62%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was weak. On the BSE, 763 shares rose and 1,859 shares fell. A total of 136 shares were unchanged.

  - ▶ U.S. Stocks Drop on Technology, Retail Earnings: Markets Wrap: -U.S. stocks fell, with disappointing earnings weighing on technology and consumer shares as investors grappled with conflicting signals on trade talks between the world's two largest economies. The dollar rose with bonds.
  - Forex- U.S. Dollar Rallies to Five-Month High: The dollar gained steam on Friday, reaching a new five-month high. The rise in bond yields, along with positive economic data and rising inflation, has boosted expectations that the Federal Reserve will increase interest rates and tighten monetary policy. The Fed raised rates in March and is expected to raise rates twice more, with some investors expecting a third hike. Expectations of higher interest rates tend to boost the dollar by making the currency more attractive to yield-seeking investors.
  - ▶ Gold Continues to Fall as U.S. Dollar Rises: Demand for gold fell on Friday, amid a strengthening U.S. dollar. Gold is denominated in the U.S. currency and is sensitive to moves in the dollar. Bullion becomes more expensive for holders of other currencies when the dollar rises. The rise in bond yields, along with positive economic data and rising inflation, has boosted expectations that the Federal Reserve will increase interest rates and tighten monetary policy.
  - Oil Prices Head for Weekly Gains Ahead of U.S. Shale Production Data: - Despite a dip in crude prices on Friday in midmorning trade, oil was still headed for weekly gains as market participants looked ahead to the latest gauge of U.S. shale production.
