MARKET COMMENTARY

The S&P BSE Sensex, rose 35.11 points or 0.10% to settle at 34,651.24. The index hit high of 34,754.60 and low of 34,550.22 during the day.

The Nifty 50 index rose 20 points or 0.19% to settle at 10,536.70. The index hit high of 10,558.60 and low of 10,490.55 during the day.

Among secondary barometers, the BSE Mid-Cap index and the BSE Small-Cap index rose by 0.65% each. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was positive. On BSE, 1450 shares rose and 1177 shares fell. A total of 142 shares were unchanged.

 - Stocks Rise as Risk-On Creeps Back; Italy Bonds Up: Markets Wrap: - A degree of risk appetite returned to global markets on Tuesday, with developing-nation stocks and currencies rebounding and the euro climbing with Italian bonds. The dollar fell as Treasury yields climbed, and the pound advanced.
 - Forex Dollar Pulls Back from 5-Month High as BoE Governor Testifies: - The dollar pulled back from a five-month high against major rivals on Tuesday, as traders opted to take profits after the recent rally, while Forex traders focused on testimony to the UK Treasury Select Committee.
 - Gold Prices Edge Higher but Stay **Near Yearly Lows**: - Gold prices were little changed in early dealings on Tuesday, hovering not far off a 2018 low struck in the previous session, as improved appetite for riskier assets sapped demand for the yellow metal. Looking ahead, the market is awaiting the minutes of the Federal Reserve's last policy meeting due to be released on Wednesday, Expectations that the U.S. central bank will lift U.S. interest rates again next month have added to recent downward pressure on gold. Higher U.S. rates tend to boost the dollar and push bond yields up, make non-yielding assets like bullion less attractive.
