MARKET COMMENTARY

The Sensex rose 209.05 points or 0.59% to settle at 35,692.52, its highest closing level since 1 February 2018. The index rose 259.61 points, or 0.73% at the day's high of 35,743.08. The index fell 4.40 points, or 0.01% at the day's low of 35,479.07.

The Nifty 50 index rose 55.90 points or 0.52% to settle at 10,842.85, its highest closing level since 1 February 2018. The index rose 69.60 points, or 0.65% at the day's high of 10,856.55. The index rose 2.45 points, or 0.02% at the day's low of 10,789.40.

The S&P BSE Mid-Cap index rose 0.90%, outperforming the Sensex. The S&P BSE Small-Cap index was up 0.54%, underperforming the Sensex.

The market breadth, indicating the overall health of the market, was positive. On the BSE, 1,441 shares rose and 1,222 shares fell. A total of 143 shares were unchanged.

 - ➤ The dollar is the 'collateral damage' of Trump's foreign policy: The US dollar has risen about 4% over the past three months. Volatility is on the rise as Trump breaks with diplomatic norms. The US dollar has rallied about 4% in recent months, and investor sentiment for the currency is the strongest in years. some analysts say that's all about to change as President Donald Trump ratchets up tensions between the US and its closest allies.
 - Oil Prices Rise Despite Supply Worries: - Oil prices were slightly higher on Tuesday despite an increase in production from OPEC. Total production of the Organization of the Petroleum Exporting Countries and Russia countries rose by 35,000 barrels per day (bpd) in May to 31.87 million bpd, according to its monthly report. However, the higher production in Saudi Arabia, Algeria and Iraq was offset by decreased production in Venezuela, Libya and Nigeria, the firm said. The organization remained cautious however, as there is "pronounced uncertainty" about the oil market outlook for the rest of the year.
