MARKET COMMENTARY

The S&P BSE Sensex, gained 196.19 points or 0.54% to settle at 36,519.96. The Sensex hit day's high of 36,549.55 and day's low of 36,261.78 in intraday trade.

The Nifty 50 index rose 71.20 points or 0.65% to settle at 11,008.05. The Nifty hit day's high of 11,018.50 and day's low of 10,925.60 in intraday trade.

Among secondary barometers, the BSE Mid-Cap index rose 2.14%. The BSE Small-Cap index rose 1.12%. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was positive. On BSE, 1,442 shares rose and 1,123 shares fell. A total of 155 shares were unchanged.

 - Forex Dollar Hits Day's Highs on **Powell Testimony:** - The dollar rose to the day's highs against a currency basket on Tuesday after Federal Reserve Chairman Jerome Powell said strong growth and stable inflation should keep the central bank on track to keep gradually raising interest rates. Fed officials believe, for now, that the best way forward is to keep gradually hiking rates in order to keep inflation close to its target amid a strong U.S. labor market, Powell said in prepared testimony before the Senate Banking Committee.
 - ➢ Gold Falls to Two-And-a-Half-Year Low on Powell Testimony: - Gold prices fell to a two-and-a-half-year low on Tuesday, as a stronger dollar weighed on the precious metal and Federal Reserve Chair Jerome Powell backed gradual rate increases.
