MARKET COMMENTARY

The Sensex rose 33.13 points or 0.09% to settle at 36,858.23, its record closing high. The index rose 122.08 points, or 0.33% at the day's high of 36,947.18. The index fell 21.95 points, or 0.06% at the day's low of 36,803.15.

The Nifty 50 index fell 2.30 points or 0.02% to settle at 11,132, its lowest closing level since 23 July 2018. The index rose 22.85 points, or 0.21% at the day's high of 11,157.15. The index fell 21.05 points, or 0.19% at the day's low of 11,113.25.

 $The S\&P \ BSE \ Mid-Cap \ index \ fell \ 0.12\%, underperforming \ the \ Sensex. \ The S\&P \ BSE \ Small-Cap \ index \ rose \ 0.23\%, outperforming \ the \ Sensex.$

The market breadth, indicating the overall health of the market, was positive. On the BSE, 1374 shares rose and 1261 shares fell. A total of 153 shares were unchanged.

 - ➤ S&P flat as gains in technology offset weak earnings: The S&P 500 was flat on Wednesday as gains in technology shares offset weak earnings from Boeing, General Motors and AT&T, while investors eyed a meeting between President Donald Trump and head of the European Commission on trade.
 - > Forex Dollar Slips, Euro Flat Before Trump-Juncker Talks: - The dollar slid against a currency basket on Wednesday and the euro was flat as U.S. President Donald Trump prepared to host European Commission President Jean-Claude Juncker for trade talks. Trump is to host a European Union delegation in the White House, with talks set to center on the auto industry amid heightened trade tensions between Europe and Washington. Last month the U.S. slapped tariffs on steel and aluminum imports from the EU, which led to Europe putting 25% tariffs on bourbon whiskey, peanut butter, motorcycles and ieans.

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
