The Nifty gained 111.05 points or 0.99% to settle at 11,278.35, its record closing high. The index hit record high of 11,283.40 in intraday trade. The index hit low of 11,210.25 in intraday trade.

The S&P BSE Mid-Cap index rose 0.95%. The S&P BSE Small-Cap index rose 0.88%.

The market breadth, indicating the overall health of the market, was strong. On the BSE, 1674 shares rose and 951 shares fell. A total of 165 shares were unchanged.

 - ▶ Best U.S. Growth in Almost 4 Years Leaves the Fed Facing Trade Uncertainty: - The second-quarter expansion in GDP showed the solid state of the American economy on Friday, but left economists questioning the stability of the numbers at hand, while offering little to change the Federal Reserve's plans for monetary policy. The U.S. economy grew 4.1% in the second quarter, in line with consensus and its strongest reading since the third quarter of 2014.
 - ➤ Forex Dollar Falls After Strong GDP Data: The U.S. dollar was lower on Friday, following a report that the U.S. economy expanded at its fastest rate in four years. The U.S. economy accelerated as expected in the second quarter, underlining the case for the Federal Reserve to gradually increase interest rates. Gross domestic product registered a seasonally-adjusted annual rate of 4.1% growth in the second quarter, its fastest rate of growth since the third quarter of 2014.
 - The euro was higher after the dollar fell, despite the European Central Bank keeping rates unchanged on Thursday and reiterating its plan to slowly end its accommodative monetary policy.
 - ▶ Oil Prices Ease Ahead of Drilling Data: - U.S. crude oil prices continued to fall on Friday as investors waited for rig count data later in the day. Data from the Energy Information Administration on Wednesday showed U.S. crude supplies fell last week. Inventories of U.S. crude fell by 6.147 million barrels for the week ended July 20, much more than expectations.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
