MARKET COMMENTARY

The Sensex rose 51.01 points or 0.13% to settle at 38,336.76, its record closing high. The index rose 201.88 points, or 0.53% at the day's high of 38,487.63. The index fell 58.39 points, or 0.15% at the day's low of 38,227.36.

The Nifty 50 index rose 11.85 points or 0.10% to settle at 11,582.75, its record closing high. The index rose 49.80 points, or 0.43% at the day's high of 11,620.70. The index fell 24.20 points, or 0.21% at the day's low of 11,546.70.

The S&P BSE Mid-Cap index rose 0.20%, outperforming the Sensex. The S&P BSE Small-Cap index fell 0.14%, underperforming the Sensex.

The market breadth, indicating the overall health of the market, was negative. On the BSE, 1217 shares rose and 1502 shares fell. A total of 176 shares were unchanged.

 - Dollar Advances Before Jackson Hole; Stocks Flat: Markets Wrap: -Stocks edged higher in thin trading as a rally in technology shares lifted U.S. equities, while the dollar gained as investors awaited the pending outcome of the latest trade talks.
 - > U.S., China Impose New Tariffs on Each Other as Talks Resume: - The U.S. and China imposed fresh tariffs on each other's goods in the middle of trade talks aimed at averting the worsening conflict between the world's two biggest economies.
 - Forex Dollar Higher amid Trump Legal Woes, Trade Concerns: - The dollar was higher against a currency basket on Thursday as fresh legal issues for U.S. President Donald Trump and an ongoing trade spat between the U.S. and China weighed on market sentiment.
 - > EIA reports a smaller-than-expected weekly rise in U.S. natural-gas **supplies**: - The U.S. Energy Information Administration reported Thursday that domestic supplies of natural gas rose by 48 billion cubic feet for the week ended August 17. Market consensus had called for a rise in the 50 billion to 55 billion cubic foot range, which would have been roughly in line with the five-year average for this time of year, according to Schneider Electric. Total stocks now stand at 2.435 trillion cubic feet, down 684 billion cubic feet from a year ago, and 599 billion below the five-year average, the government said.


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
