#### **TOP STORY**

- Reliance Infrastructure board approved 100 percents ale of integrated Mumbai power business to Adani Transmission.
  - Aditya Birla Capital and Varde Partners create a <u>joint venture to invest in stressed assets</u> in India. Varde Partners will acquire 50 percent stake in Aditya Birla ARC for at least Rs 98 crore.
- Laurus Labs received the U.S. Food and Drug Administration's approval for Metformin Hydrochloride tablets, which are used for treatment of diabetes. The product and the active pharmaceutical ingredient will be commercialised from the company's unit two located in Visakhapatnam.
- **Greaves Cotton** board has approved acquiring 67 percent stake in Ampere Vehicles Pvt. for Rs 77 crore, option of acquiring another 13 percent stake in the electric vehicle company for Rs 75.5 crore.
- ICICI Prudential Life Insurance reduced its stake in Tata Chemicals from 5.02 percent to 2.97 percent. The company offloaded 52.1 lakhs hares of the chemical company for Rs 216 crore.
- National Fertilizers signed memorandum of agreement with Ramagundam Fertilizers and Chemicals Limited to market the latter's product including 12.71 LMT of urea under its brand 'Kisan'.
- Jain Irrigation said that it has received a contract worth Rs 127 crore from the Rwandan government for developing irrigation and watershed facilities. This was an engineering, procurement and construction contract and the company said that it will complete the project on next 18 months, *PTI* reported.
- Jet Airways introduced 28 new flights in September to enhance domestic connectivity.

# **MARKET COMMENTARY**

The Sensex, lost 173.70 points or 0.45% to settle at 38,722.93. The Sensex rose 93.02 points, or 0.24% at the day's high of 38,989.65 in early trade. The index fell 217.06 points, or 0.56% at the day's low of 38,679.57 in late trade.

The Nifty 50 index fell 46.60 points or 0.40% to settle at 11,691.90. The Nifty rose 14.70 points, or 0.13% at the day's high of 11,753.20 in early trade. The index fell 59.65 points, or 0.51% at the day's low of 11,678.85 in late trade.

Among secondary barometers, the BSE Mid-Cap index rose 0.47%. The BSE Small-Cap index rose 0.05%. Both these indices outperformed the Sensex.

The market breadth, indicating the overall health of the market, was negative. On BSE, 1281 shares rose and 1429 shares fell. A total of 166 shares were unchanged.

  - Wall Street up slightly as tech stocks gain: - U.S. stocks rose slightly on Wednesday, lifted by technology stocks, though gains were limited as investors awaited progress on U.S.-Canada trade talks and eyed a deadline for consultations on the next round of China-U.S. tariffs.
  - > Forex Dollar Dips, Pound Rallies on Barnier Comment: - The dollar edged lower against a basket of the other major currencies on Wednesday, as the pound rallied after comments on Brexit by European Union negotiator Michel Barnier. Market sentiment was supported by hopes that Canada will join the new trade agreement between the U.S. and Mexico aimed at overhauling the North American Free Trade Agreement.
  - Gold Edges Lower as Trade Tensions Continue: - Gold prices were lower on Wednesday as Sino-U.S. trade tensions continued. Investors remained cautious ahead of an upcoming deadline in Sino-U.S. trade disputes as a trade deal between the U.S. and Mexico was underway.
  - WTI Oil Futures Extend Gains After **Crude Inventory Data**: - West Texas Intermediate oil extended gains in North American trade on Wednesday after weekly data showed that oil supplies in the U.S. registered a larger-thanexpected draw. The U.S. Energy Information Administration said in its weekly report that crude oil inventories fell by 2.566 million barrels in the week ended August 24. Market analysts had expected a crude-stock draw of 0.686 million barrels, while the American Petroleum Institute late Tuesday reported a supply increase of 0.038

# **Arbitrage**


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
