MARKET COMMENTARY

The Sensex fell 139.61 points or 0.37% at 38,018.31, its lowest closing level since 17 August 2018. The index rose 92.69 points, or 0.24% at the day's high of 38,250.61. The index fell 383.50 points, or 1.01% at the day's low of 37,774.42.

The Nifty 50 index fell 43.35 points or 0.38% at 11,476.95, its lowest closing level since 17 August 2018. The index rose 22.35 points, or 0.19% at the day's high of 11,542.65. The index fell 126.45 points, or 1.10% at the day's low of 11,393.85.

The S&P BSE Mid-Cap index fell 0.61%. The S&P BSE Small-Cap index fell 0.52%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was weak. On the BSE, 1041 shares rose and 1719 shares fell. A total of 170 shares were unchanged.

Crude had jumped the previous day as oil companies shut dozens of offshore platforms in anticipation of damage from tropical storm Gordon. But by Wednesday the storm was weakening, reducing its threat to oil producers.
 - ➤ Natural Gas Price Fundamental Daily Forecast Weighed Down by Rising Production, Could Strengthen Over \$2.838: Technically, the main range is \$2.688 to \$2.794. The market is currently testing its 50% to 61.8% retracement zone at \$2.833 to \$2.799. Trader reaction to this zone is likely to determine the near-term direction of the market. Look for an upside bias today if buyers can overtake \$2.838. The downside bias will continue if \$2.799 fails as support.

Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
