

- <u>Sun Pharma</u>: In its clarification note related to Mohali plant, company said the US FDA is conducting an inspection of Mohali facility (Punjab,India). The inspection started on September 10 and is ongoing.
- <u>Cipla</u>: The South African Health Products Regulatory Authority (SAHPRA) has approved Cipla's lates t first-line triple-combination antiretroviral (ARV) treatment for HIV.
- Adani Green: Company has incorporated a wholly-owned subsidiary company Adani Saur Urja (KA).
- <u>Satin Creditcare Network</u>: Company in next few months will file application with RBI for NBFC license of Satin Finserv and will transfer entire MSME business to new entity Satin Finserv.
- Yes Bank: Its Rs 4,000 crore proposed Basel III Tier 2 bonds receive AAA rating from CARE Ratings and AA+ from India Ratings & Research with a Stable outlook.
- <u>Godrej Agrovet</u>: Board, on September 14, to consider scheme of amalgamation of Astec LifeSciences (a subsidiary) with the company and also to discuss on business strategies.
- Reliance Industries' Reliance Jio and Bharti Airtel received demand notices towards penalties totalling to Rs 34 lakh and Rs 11 lakh respectively from the TRAI
- Housing and Urban Development Corporation: HUDCO has achieved the level of loan sanctions of Rs 4,094.91 crore and loan releases of Rs 3,021.66 crore,

#### **MARKET COMMENTARY**

The Sensex fell 509.04 points or 1.34% to settle at 37,413.13, its lowest closing level since 2 August 2018. The index rose 121.10 points, or 0.32% at the day's high of 38,043.27. The index fell 560.97 points, or 1.48% at the day's low of 37,361.20.

The Nifty 50 index fell 150.60 points or 1.32% to settle at 11,287.50, its lowest closing level since 2 August 2018. The index rose 41.30 points, or 0.36% at the day's high of 11,479.40. The index fell 164.10 points, or 1.43% at the day's low of 11,274.

Among secondary barometers, the BSE Mid-Cap index fell 1.36%. The BSE Small-Cap index was fell 1.37%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was weak. On BSE, 874 shares rose and 1841 shares fell. A total of 152 shares were unchanged.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



## **Arbitrage**

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
