- . IL&FS Financial Services: Company defaulted on 7 repayments between September 12 & 27.

MARKET COMMENTARY

The Sensex fell 218.10 points or 0.60% to settle at 36,324.17, its lowest closing level since 24 September 2018. The index rose 169.35 points, or 0.46% at the day's high of 36,711.62. The index fell 304.04 points, or 0.83% at the day's low of 36,238.23.

The Nifty 50 index fell 76.25 points or 0.69% to settle at 10,977.55, its lowest closing level since 24 September 2018. The index rose 35.65 points, or 0.32% at the day's high of 11,089.45. The index fell 100.45 points, or 0.91% at the day's low of 10,953.35.

Broader market fell steeply. Among secondary barometers, the BSE Mid-Cap index fell 2.19%. The BSE Small-Cap index fell 1.97%. Both these indices underperformed the Sensex.

The market breadth, indicating the overall health of the market, was weak. On BSE, 768 shares rose and 1814 shares fell. A total of 156 shares were unchanged.

 - > U.S. Stocks Rise as Dollar Climbs to Two-Week High: Markets Wrap: -U.S. stocks climbed and the dollar jumped to a two-week high as investors digested the likelihood of more Federal Reserve interest-rate increases stretching into next year.
 - Forex Dollar Gains Ground as Markets Digest Fed Rate Hike: - The dollar gained ground against the other major currencies on Thursday as markets digested the Federal Reserve's widely expected rate hike and indications that its remains on track to continue monetary tightening into next year.
 - > Gold Prices Slip below \$1200 as Fed Rate View Weighs: - Gold prices dipped below the psychologically important \$1,200 level on Thursday, finding little support after the Federal Reserve raised interest rates and indicated that it remains on track to continue monetary tightening into next year. The Fed raised interest rates by a quarter point to 2.25% on Wednesday, its third rate hike this year and its eighth since 2015. In its statement, the Fed said it still foresees another rate hike in December followed by three more in 2019, and one additional increase in 2020.
 - Oil Prices Hovering Near 4-Year Highs amid Supply Shortage Fears: -Oil prices were hovering near the \$82 a barrel level on Thursday, close to the four year highs reached earlier in the week amid fears of a supply shortage as the U.S. prepares to re-impose sanctions on Iran from Nov. 4.


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
