Titan Company: While the Watch business carried on its good run from the first quarter, the growth in the Jewellery business picked up very well after a relatively soft growth in Q1'19.

MARKET COMMENTARY

The Sensex fell 806.47 points or 2.24% to settle at 35,169.16. The index fell 155.10 points, or 0.43% at the day's high of 35,820.53. The index fell 953.51 points, or 2.65% at the day's low of 35,022.12.

The Nifty 50 index fell 259 points or 2.39% to settle at 10,599.25. The index fell 103.55 points, or 0.95% at the day's high of 10,754.70. The index fell 311 points, or 2.86% at the day's low of 10,547.25.

Among secondary equity barometers, the BSE Mid-Cap index fell 1.93%. The BSE Small-Cap index fell 2.07%.

The market breadth, indicating the overall health of the market, was weak. On BSE, 779 shares rose and 1885 shares fell. A total of 138 shares were unchanged.

 Treasuries Hold Steady: Markets
 Wrap: U.S. stocks fell as ratesensitive shares tumbled after Treasury
 yields surged to multiyear highs. The
 dollar fell versus the euro and yen. The
 S&P 500 fell to a three-week low, with
 real-estate and consumer shares bearing
 the brunt of selling. Technology heavy
 Nasdaq indexes also retreated, while
 financial firms surged after the 10-year
 yield poked above 3.2 percent for the
 first time in seven years before pulling
 back.
 - Forex- Dollar Falls; Sterling Rises as Brexit Talks Near End: The U.S. dollar eased back from earlier highs on Thursday, as 10-year Treasury yields continued to climb. The U.S. dollar index, which measures the greenback's strength against a basket of six major currencies, fell 0.37% to 95.32. The yield on the benchmark 10-year Treasury notes rose to levels not seen since 2011 after upbeat economic data and hawkish comments from Fed Chairman Jerome Powell bolstered expectations of an interest rate increase in December.
 - ➢ Gold Prices Hit Fresh 2-Week Highs as Dollar, Wall St. Slide: - Gold prices rose to fresh two-week highs on Thursday as the dollar reversed early gains and U.S. stocks opened lower as a spike U.S. bond yields weighed, bolstering safe haven demand for the precious metal.
 - ➢ Oil Prices Retreat from 4-Year Highs: - Oil prices retreated from fouryear highs on Thursday, a day after data pointing to the largest biggest build in U.S. crude stockpiles since March 2017 and reports that Russia and Saudi Arabia


Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
