<u>Yes Bank</u>: Company has appointed two former chairmen -- TS Vijayan of LIC and OP Bhatt of SBI to its search and selection committee to find a successor for Rana Kapoor.

<u>Indiabulls Housing Finance</u>: Company has redeemed (bought back) secured, redeemable, non-convertible debentures of face value Rs 10,00,000 each. Additionally, the company has bought back Rs 1,505 crore of commercial paper since September 21, 2018 till date.

MARKET COMMENTARY

Nifty PSE index ended down 8.05% at 3205.9 today. The index is down 11.00% over last one month. Among the constituents, Hindustan Petroleum Corporation Ltd slipped 23.97%, Bharat Petroleum Corporation Ltd dropped 19.89% and Indian Oil Corporation Ltd fell 15.86%. The Nifty PSE index is down 21.00% over last one year compared to the 4.33% surge in benchmark Nifty 50 index. In other indices, Nifty Energy index is down 7.97% and Nifty Commodities index has dropped 6.18% on the day. In broad markets, the Nifty 50 has slid 2.67% to close at 10316.45 while the SENSEX is down 2.25% to close at 34376.99 today.

 - Treasuries Drop on Jobs Data, Tech Selloff Resumes: Markets Wrap: -Treasury yields rose to seven-year highs amid speculation the latest jobs report clears the path for raising interest rates. U.S. stocks headed for a second weekly decline, with technology shares under renewed pressure.
 - > Forex U.S. Dollar Falls After Jobs Report: - The U.S. dollar fell on Friday after the September jobs report came in lower than expected and 10-year Treasury yields rose to a seven-year high. The U.S. economy created less jobs than expected in September, but unemployment reached a 48-year low, indicating the economy could be plateauing. Nonfarm payrolls rose by 134,000 compared to expectations for a 185,000 gain.
 - Crude Advances as Alarm Bells Sound Over Impending Supply **Crunch**: - Oil headed for the longest run of weekly gains since the start of 2018 amid concern that Saudi Arabia and Russia may not pump enough crude to prevent a supply crunch as Iranian cargoes disappear from world markets.
 - > Gold Prices Rise as Dollar Falls After Jobs Report: - Gold prices rose on Friday as the greenback pared back earlier gains after September's payroll numbers came in lower than expected. The U.S. economy created fewer jobs than expected in September, but unemployment reached a 48-year low, indicating the economy was nearing full employment. The disappointing payrolls numbers pushed the dollar lower, despite increased expectations of a Federal Reserve rate hike in December.

The act or practice of buying stocks only to resell them at a profit very quickly. Stock jobbing is a short-term investment strategy that operates on the assumption or existence of liquid markets.

This Trading algorithm is designed basically for jobbing:

Pre Defined Stop Loss
Pre Defined Risk
Buy-Sell Both
Carry Forward



Arbitrage

Arbitrage Stands for Simple Buying and Selling stocks but in another exchange. A Simple Arbitrage Example
As a simple example of arbitrage, consider the following. The stock of Company X is trading at 100 on the NSE while, at the same moment, it is trading for 100.50 on the BSE. A trader can buy the stock on the NSE and immediately sell the same shares on the BSE, earning a profit of .50 per share.
